Dear Justice McAllister,

I write to you with concern regarding a particular section of the state Senate district maps drafted by Special Master Professor Jonathan Cervas - namely the southwest corner of the proposed Senate District 25 that is bordered by a triangular formation by Flatbush Avenue, Warren Street/Prospect Place, and 4th Avenue in Brooklyn.

As I am sure Your Honor is aware, the New York State Constitution requires that when the Independent Redistricting Commission drafts legislative districts, they "shall consider the maintenance of cores of existing districts, of pre-existing political subdivisions, including counties, cities, and towns, and of communities of interest" (NY Const, art III, § 35 [c] [5]). I do believe the boundaries drawn by the Special Master, in the Commission's stead, violate that requirement.

In the spirit of full disclosure, please note that I am currently a candidate for Democratic State Committee for Kings County's Assembly District 52. Throughout my candidacy, I have listened intently to the concerns of the people I wish to represent. To that end, approximately three weeks ago, I had a campaign stop in the Park Slope section of Brooklyn along Bergen Street, just south of the Barclays Center – the area of my concern. Many of the people with whom I have spoken told me of concerns they had regarding traffic enforcement and a lack of green space in that area. Those residents told me of their efforts at advocating with their elected representatives and other government officials for assistance on those issues. I bring this to The Court's attention because my concern is that by splitting that section of Park Slope out of the rest of the senatorial district, there will not be a unified community voice, via a single state senator, on those kinds of hyperlocal concerns.

If the district lines, as drafted by Professor Cervas, are any indication, whoever the senator is for Senate District 25, I fear will focus on the concerns of the constituents in the Fort Greene, Clinton Hill, Bedford-Stuyvesant, Prospect Heights, Ocean Hill, and Brownsville sections of Brooklyn since those neighborhoods would undoubtedly constitute the areas where

the majority of the senator's constituents reside. To that end, the small triangularly-shaped area of Park Slope to which I am referring currently has, by the last count, 2,349 voters (the total population no doubt being likely slightly larger). With each senate district containing roughly 309,682 residents (calculated by dividing the New York State population of 19.51 million, as determined by the 2020 Census, by the 63 seats in the New York State Senate), the constituents in question equate to less than 0.76% of the total senatorial district's population. If the sheer numbers are any indication, it would seem inevitable that the needs of the neighborhoods with more constituents would likely take priority. I am sure Your Honor would agree that neighborhoods would certainly constitute a community of interest.

With that in mind, I would like to inform Your Honor that the current and new Assembly district map, as well as the 2012 Senate map, all keep that section of Park Slope together with Boerum Hill to the west since they share similar community concerns. The New York State Constitution requires that, when drawing legislative boundaries, the Special Master - taking the place of the Independent Redistricting Commission - "shall consider the maintenance of cores of existing districts, [and] of pre-existing political subdivisions." Since the aforementioned current and future district boundaries all keep this one section of Park Slope together, the senate districts should as well.

Moreover, on the matter of the "maintenance of cores of existing districts, [and] of pre-existing political subdivisions," the boundary lines drawn for the proposed Senate District 25 violate that requirement for another reason.

Pending any further litigation, the district lines that have been drawn for the Assembly and the subsequent election districts, which are, of course, political subdivisions of the Assembly district, are subject to this Court's ruling last week. However, the Court should be made aware that the proposed Senate District 25 bifurcates Election District 72 of Assembly District 52 by adding a border through Warren Street/Prospect Place (for the Court's convenience, I have included a map, in Figure 01, which overlays the Election District map for the area, as drawn by the New York City Board of Elections, with the proposed senate map). As the Court knows, each election district must reside in exactly one congressional district, one senatorial district, and one assembly district (Election Law, art 15, § 4-100 [3], [a]). Since Election District 72 in question is certainly a "pre-existing political subdivision," the proposed Senate District 25 boundaries, as drafted, violate that rule. The only remedy for the election district in question would be for the New York City Board of Elections to redraw the Election

District 72 so that it is no longer split between two senatorial districts. However, since election districts must also be of roughly equal population, ranging from nine-hundred fifty to eleven-hundred fifty, the remedy for Election District 72 would have a cascading effect on the rest of the Assembly District 52's (Election Law, art 15, § 4-100 [3], [a]), causing all its Election Districts to be re-drawn. I note that hundreds of candidates for the Kings County Democratic County Committee in the Assembly District 52, including those in Election Districts 72 and 73, which would be most impacted, have already gathered and submitted the requisite ballot petition signatures to serve on the County Committee and this proposed map would potentially disenfranchise them.

As a solution, I ask the Court to move the area of Park Slope bordered by Flatbush Avenue, Warren Street/Prospect Place, and 4th Avenue from the proposed Senate District 25 into the proposed Senate District 26 where it will undoubtedly be able to can unify its voice with the residents of Boerum Hill to the west. This can simply be done by moving the border that divides Senate Districts 25 and 26 to Flatbush Avenue in order to coincide with the district lines for Assembly District 52.





To whom it may concern,

I am writing to express my dismay at the most recent redistricting map from the Special Master. I live in the Northwest Bronx, which has been split off from lower Westchester, diminishing the voices of Black voters. NYCD16 has been represented by a powerful Black voice in the House. The redrawn lines reduce the Black voter population by 17% putting our fine incumbent at risk.

Marginalization of an under-represented community is unacceptable. We are still in the early phase of shifting from a shamefully low number of non-white elected officials to a more appropriately representative government at every level.

The Northeast Bronx communities of Co-op City, Williamsbridge, Edenwald and Baychester are split off from NYCD16 into other districts which further reduces the impact of Black voters, who, as a community of shared interest, should not be divided in this manner. That end result is in violation of the stated intent to maintain communities of shared interest within new district lines.

This most recent map can not move forward without causing harm to voters already disempowered and under attack.
