Multiple organizations exemplify this connection, including ACE Collective - Alliance for the Creative Economy (ACE), a project of the Center for Economic Growth (CEG). #### To Whom It May Concern:

I am writing in response to the draft Congressional map released earlier this week. I am a resident of Columbia County, and the proposed changes would have disastrous consequences for our county. If allowed to stand, Columbia County would be separated from both the Capital District and the Mid-Hudson Valley regions, as well as its county neighbors to the north and south. The proposed map groups our county with Southern Tier and Finger Lakes counties, with which it has no commonality or relationship. This is unprecedented and would result in a poor outcome for our county when it comes to identity, representation, and allocation of resources.

Columbia County is located along the Hudson River in the Mid-Hudson Valley, and the Department of Economic Development has placed Columbia County in the Capital District. Under the proposed map, Columbia County would be isolated from both regions and be the only county in CD19 on the east side of the Hudson River. Columbia County should be part of a contiguous district of adjoining Mid-Hudson Valley counties. Based on current 2020 Census data, the combined populations of Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties would be 748,393 people, which is within the range of +/- 10 percent of the average congressional district.

Columbia County has been excised from its peers and placed in a congressional district that shares little in common administratively. Our judicial, assembly, and senate districts have little, if any, overlap with other counties included in the proposed CD19. Effective government requires coordination and collaboration. As a 26 year resident of Columbia County, I am writing in response to the draft Congressional map released earlier this week. I am a resident of Columbia County, and the proposed changes would have disastrous consequences for our county. If allowed to stand, Columbia County would be separated from both the Capital District and the Mid-Hudson Valley regions, as well as its county neighbors to the north and south. The proposed map groups our county with Southern Tier and Finger Lakes counties, with which it has no commonality or relationship. This is unprecedented and would result in a poor outcome for our county when it comes to identity, representation, and allocation of resources.

Columbia County is located along the Hudson River in the Mid-Hudson Valley, and the Department of Economic Development has placed Columbia County in the Capital District. Under the proposed map, Columbia County would be isolated from both regions and be the only county in CD19 on the east side of the Hudson River. Columbia County should be part of a contiguous district of adjoining Mid-Hudson Valley counties. Based on current 2020 Census data, the combined populations of Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties would be 748,393 people, which is within the range of +/- 10 percent of the average congressional district.

Columbia County has been excised from its peers and placed in a congressional district that shares little in common administratively. Our judicial, assembly, and senate districts have little, if any, overlap with other counties included in the proposed CD19. Effective government requires coordination and collaboration. The proposed map diminishes Columbia County's political power.

New York's 16th Congressional District must retain the northeast Bronx communities of Co-op City, Baychester/Williamsbridge, and the Edenwald, combined with lower Westchester County.

The most recently redrawn special master's proposed map, decreases the Black and Brown voter population by about 17%, which ultimately dilutes the voting power of Black and Brown people in the New York -16th Congressional District.

The proposed map will only further marginalize our community, and in the process, make it difficult to elect candidates that best represent our interests.

The newly proposed map will splinter the northeast Bronx's predominantly Black and Brown community into three congressional districts: Co-op City would be mapped into New York's -14<sup>th</sup> Congressional District, Williamsbridge and Baychester communities will be mapped into the New York's -15<sup>th</sup> Congressional District, and only the Edenwald community will be kept in the New York -16<sup>th</sup> Congressional District.

This redistricting map only serves to divided and diminish the Black and Brown voter population in New York's 16<sup>th</sup> Congressional District, all of which have very similar Congressional representative needs.

I write to you as the Superintendent of the Malverne UFSD with concerns over the impact the new congressional maps will have on the students of Lakeview and our entire school community. We are a high performing district of color that may be one of New York's best hopes for understanding how setting high expectations for students and supporting them to achieve can be accomplished. We have been able to do this because we can call on our local legislators to support us in numerous efforts that our state aid can not cover. Such aid has come consistently from legislators like Judy Griffin, Tom Kaminsky and Taylor Darling, who know and support our community.

While we are still mourning with the families and citizens of Buffalo over the recent racially motivated shooting deaths, the maps were released for the Congressional and Senate areas. These maps are devastating for our African American communities all over the state and it directly impacts our local community of Lakeview. Woodfield Road is a symbol to Lakeview and our entire school community. It is there that our Woodfield Road Elementary school was located when we received our order to desegregate in 1965. Rev. Dr. Martin Luther King visited there to help us in these efforts. The new maps seek to split the residents of Woodfield Road into two districts. This one act would cause this historic African American community to lose their collective voice in choosing their state representatives. Our well-known legislators will be lost and the voting power of the residents of Lakeview will be drastically diluted and diminished. As such, the current map violates the New York State Constitution, Article III, Section 4(c)(1), which specifically prohibits the creation of political districts that abridge the voting rights of racial minority voting rights.

There does not appear to be any valid reason why the small cohesive community of Lakeview should suddenly be divided into two election districts. If this map is accepted, Lakeview and the Malverne School District will be weakened while the focus from our elected officials will be diffused between

Dear Jonathan Cervas,

As a resident and taxpayer of Greene County, NY, I am very upset about the newly defined redistricting map. Separating Columbia and Greene Counties is inefficient, and neglects the history of our twin counties working together. Currently we share a hospital and physical and mental health care system, a community college, addiction recovery resources, Cornell Cooperative Extension, and, to a large extent, an economy. The growth that is beginning is tied to the overall revitalization of the Hudson Valley in Upstate NY, and like many others I moved from Columbia to Greene county. Please reconsider this map which identifies common cause with the Southern Tier of New York, which simply is not our lived reality.

Greene County is included in the description of the <u>Capital Region</u> which includes Albany, Columbia, Greene, Rensselaer, Saratoga, Schenectady, Warren, and Washington Counties. Multiple organizations exemplify this connection, including ACE Collective - Alliance for the Creative Economy (ACE), a project of the Center for Economic Growth (CEG). ACE is dedicated to promoting and growing the Creative Industries in the 8-county Capital Region - <a href="https://www.upstatecreative.org">https://www.upstatecreative.org</a>.

Our economic, social and tourist interaction with our longstanding partner, Columbia County, is exemplified by the name of our local Community College, Columbia-Greene Community College. This partnership is further emphasized by how many organizations are shared by the "Twin Counties", Columbia County and Greene County.

While we are divided by the Hudson River, we share the responsibility for the estuaries and other environmental aspects of the shores of the Hudson River, even though we may not be on the same side of the Hudson.

Separating Greene County from Columbia County, the Hudson River, and Capital Region, in any capacity, is unthinkable for Greene County residents. This is a community element, as well as something distinguished in many publications, now and throughout the past. The Hudson Valley is a part of the Catskill Mountains, which is the heart of Greene County.

We understand that this process to redraw maps has had to happen quickly, please do not discount the vital relationship between Columbia and Greene County, nor our relationship to the Hudson Valley and the Capital Region. This is our home.

#### Dear Judge McAllister:

I write to express my urgent concerns regarding the most recent proposed congressional redistricting map - drawn by Jonathan R. Cervas, the court-appointed special master, and released publicly on Monday, May 16, 2022 – given your current judicial oversight of New York's redistricting process. Thank you for the opportunity to submit comment.

As a lifelong New Yorker hailing from the Lower East Side and as a proud Latina, I am honored to represent New York City's 2nd Council District.

For far too long, the redistricting process has advanced the interests of the most powerful while seeing the electoral power of marginalized communities as incidental, including New York's large and diverse Latino population. Generally speaking, Latinos now make up 19% of the state's population and represent a range of ethnic and racial backgrounds. By reducing the current congressional representation of neighborhoods central to our communities to just three districts, Latino New Yorkers fall short of their due representation in the federal delegation.

Above all, I believe the current map fails to consider the devastating impact of fracturing longstanding Latino neighborhood partnerships. Among the most concerning distinctions between the New York Independent Redistricting Commission maps and the map drawn by the court-appointed special master is New York's 7th Congressional District, whose current community of interest has been reduced by approximately 50%, threatening to dilute and disregard Latino electoral power. For the past three decades, the 7th District has included culturally-linked and physically-similar neighborhoods such as the Lower East Side, Sunset Park, and Red Hook, that collectively produce a majority of minority groups. The draft congressional maps still provide an opportunity to reconnect at least some of these neighborhoods, particularly by adjusting Brooklyn district lines.

I recognize that we share a common goal to ensure that the New York State redistricting process strengthens our representative democracy. Considering the significant growth of the Latino population in New York and of the contributions of Latinos statewide, I urge the Court and Special Master to consider revisions which better reflect links between long-standing communities of interest in both our city and state. Thank you for your consideration.

We were surprised and concerned to see the proposed alterations to the 20th Congressional District. Breaking Amsterdam and Saratoga away from a district that has traditionally represented all of the Greater Capital Region seems counterproductive to us.

#### The Greater Capital Region has long

worked together to coordinate major projects beneficial to the entire 20th CD at every level -- local, state, and, perhaps most important, federal.

Both Amsterdam and Saratoga share strong bonds with the Capital District. Many of their residents regularly travel to the Albany area for employment or entertainment. The presence of coordinated transportation infrastructure is essential to all our communities, whether through highways, public ground transportation (now regionally coordinated through CDTA), or rail.

As but a couple of examples: First, planning for greater access to and service from Albany International Airport is critical to Saratoga's high-tech and entertainment industries. Second, planning for more efficient rail travel from Albany west is of paramount importance to a small city such as Amsterdam. How would these critical infrastructure needs, which require federal funding, be better met by placing these communities in a North Country District, which has vastly different priorities and fewer resources?

We respectfully request therefore that Amsterdam and Saratoga remain in the 20th CD, where they can best receive the regional representation they deserve and which will strengthen the Capital Region as a whole.
