Dear Judge McAllister and Special Master Cervas:

By way of introduction, I am Bernell Grier, Executive Director of Pratt Area Community Council, Inc. d/b/a IMPACCT Brooklyn (IMPACCT Brooklyn). IMPACCT Brooklyn is the premier community development corporation serving Brooklyn, New York with a focus on Central Brooklyn. Central Brooklyn includes the neighborhoods of Fort Greene, Clinton Hill, Bedford Stuyvesant, Crown Heights, Ocean Hill Brownsville, Prospect Heights, and Lefferts Gardens. These areas have historically been occupied by families descending from the Black African diaspora.

We at IMPACCT Brooklyn worked diligently to have members of the community complete the census. Our area did better in count than in the past: nevertheless, the census still resulted in there being a lessening of one Congressional seat within New York State. New York State currently comprises 27 congressional districts. The state was redistricted in 2013, following the 2010 U.S. Census; it lost two seats in Congress. Starting in the 2022 mid-term elections, per the 2020 United States census, New York will lose a congressional seat. The loss was decided by a remarkably close margin; it was believed that if 89 more people were counted in the census results and all other state populations remained stagnant, New York would have kept its lost seat.

Most recently we have been following the news on how district maps are being re-classified. We believe there is an equitable solution to redesigning the districts. However, the current map as

presented by Jonathan Cervas, the court-appointed "special master," is unfair to the community that IMPACCT Brooklyn has long served (as well as other areas within the New York State).

We agree with House Democratic Caucus Chairman Hakeem Jeffries that the draft redistricting map viciously targets historic Black representation in NY. Unfortunately, at this time in United States history, racism as evidenced by the constant attacks (as recent as in Buffalo New York) resulting in the death of Black people leaves the community at large skeptical. A close examination of the redesigned map dilutes the Black population in the 8th and 9th congressional districts in a manner wildly inconsistent with the constitutional mandate that communities of color should be put into a position to elect the candidate of their choice. We still celebrate the Late Shirley Chisholm whose district was created in 1968 pursuant to the Voting Rights Act of 1965, with the Bedford Stuyvesant neighborhood at its core. This proposed map now breaks up this majority Black and historic neighborhood of Bedford Stuyvesant. The work of redistricting cannot be done without a racial equity lens.

Brooklyn residents, civic leaders, and stakeholders made clear that the communities of interest that presently constitute the 8th and 9th congressional districts should be kept together, as was the case in maps submitted by good government groups like Common Cause, civil rights groups like the Unity Coalition and even the Independent Redistricting Commission. The Court needs to review and accept the recommendations made under the comprehensive testimony of the voices of the community. IMPACCT Brooklyn serves the areas within these Congressional Districts. Bedford Stuyvesant has been gerrymandered, ignored, discriminated and discounted in the past, but to see it happening now is unbelievable.

I am the Executive Director of IMPACCT Brooklyn and I reside in the community we serve. The community has long been a predominantly black community, and throughout history, we have fought to be able to organize and vote together in order to fight for our shared needs in our community. We call for further discussion and equity within as redistricting moves ahead.


Subject: Comment for Special Master

Please accept the following as a comment on the NYS Senate maps proposed by the Special Master on Monday the 15th.

I appreciate the work that has been done to change these maps, but want to suggest that to combine communities of interest in Rochester, NY that the 55th and 56th Senate districts be slightly altered. Instead of following the arbitrary lines set in the last maps, my recommendation is to split the majority of the city along the Genesee river until you reach the South Wedge where the expressway would be used as a line of demarkation until you reach the Swillburger neighborhood. From there the line between district would go from South Goodman to South Clinton before turning southeast until it reaches the Brighton border.

Not only would this create cleaner lines according to the Reock method of compactness, it would also unite neighborhoods and educational institutions. These new lines would also have minimal impacts on minority vote share.
