My name is Roger Gendron and I am the President of the New Hamilton Beach Civic Association in Hamilton Beach. On behalf of the community members of Howard Beach, Queens, we are writing to urge you to protect the future of our community and swiftly reconsider the proposed redistricting maps. The residents of Howard Beach are inextricably connected through proximity, common values, mutual challenges, and shared lived experiences.

In the wake of the devastation and aftermath of Hurricane Sandy in 2012 and Hurricane Ida in 2021, much of the Eighth Congressional District has become unified in our fight for a solution to address our communal needs. Following both natural disasters, neighborhoods in the southern end of the district, including Mill Basin, Bergen Beach, Marine Park, Plumb Beach, Manhattan Beach, Brighton Beach, Coney Island and Howard Beach all experienced severe flooding and water damage. Many of our homes became inhabitable following these severe storms and have only become more vulnerable as the effects of climate change worsen. Day by day, our coastal community is being rebuilt, but a great deal of work is still needed.

The residents and businesses of Howard Beach and Hamilton Beach form a "community of interest" with the Brooklyn neighborhoods, such as Canarsie and Mill Basin, located on the coast of Jamaica Bay. Good afternoon, Judge McAllister. First allow me to express my appreciation for the staff person who answered the phone and shared this email address with me. Her kindness and professionalism are to be commended. I have advised others not to call but to send their own emails regarding the district maps released two days ago.

Regarding the draft district maps...

I am a resident of Chester, NY. As you know one of the quirks of residing in Chester is the experience of being split away from different parts of the community across odd lines for the purpose of property taxes. To illustrate my point, my neighbors and I pay property taxes to WARWICK. Our lived experiences are in Chester, but the value of our homes go to benefit Warwick. This deal of splitting residents in far flung communities for the purpose of capturing property taxes is truly senseless and yet there is nothing that can be done about it.

The draft district map released on Monday is a repeat of the same thing. The only difference is that YOU can do something about that today.

Due to the way the map is drawn, Chester is worse off in being able to effect its right to have representation in Congress. The new map lumps Chester in with far too many larger communities that have economic and environmental issues that would lead to our disenfranchisement. Just looking at the map you can see that both the 18th and 19th districts are too vast and cram together too many communities with divergent needs that should be addressed by the policies and resources of the federal government within lines of strange confinement-- almost ensuring no needs will ever get met. (I believe the 21st district is ridiculously large.) Consider the issues of wetlands, well water protection, hunting, loss of land for mega developments with no infrastructure investments, lake and pond protection from dumping, decline in local farming, sudden growth of deed theft scams... all of these issues need to be addressed to preserve our community. We need to be drawn into a map with communities who have the same or similar needs.

Please send the draft map back and have the Special Master re-draw it. My request is to redraw lines of the 18th and 19th... maybe the 17th, too, and add another proper district among them. There should be respect for obvious breaks between communities and commonalities of population size and needs that doesn't lead to disenfranchisement, choking off of the ability of residents to get their issues addressed by their government. Chester + Warwick + Goshen + Middletown + Monroe + Tuxedo + Woodbury + Wallkill + Blooming Grove ... and Monticello should be a stand alone district. If that is not large enough then add Highlands, Cornwall, and New Windsor.

The new draft map punishes towns like Chester and obscures our existence. That can not be good for New York.



Per state law, protecting communities of interest must be the priority, not compactness that in this instance demonstrates either shocking unfamiliarity with NY neighborhoods or deliberately abuses county and subdivisional boundaries that do not reflect community realities. For example, separating Mount Vernon and Yonkers from the Bronx, and cutting the Asian community in sunset park three or four ways. And much more.

The most judicious correction with limited time is to start with the 2012-2020 maps that went through a similar process but thru federal intervention before Shelby and Abbott decisions—thus has a considerable amount in common with NY state constitution re: protection of communities of interest like racial minorities. Then remove one district while ensuring that the new map (1) protects communities of interest, and (2) leans on the 2012-2020 map, a federally approved design, as an accountability measure to ensure that communities of interest are protected to greatest possible extent.

The Master's decision to put his own stamp on the map and throw past maps out the window is incredibly inappropriate particularly since the confusion will be more injurious to communities of interest.



To whom it may concern,

There are few areas in New York where the Census found deep concentrations of Latino New Yorkers like the Bronx. In fact, Bronx county is the only county in the State of New York where the majority of residents are Latino, at 54.8%. That's nearly double the proportion of Latinos in Queens and more than double the proportion in New York county.

Bronx county has the most census tracts with a majority of Latino residents. The Special Master's maps draw Senate district lines that split up this majority Latino population into four different Senate districts, one of which crosses county lines, effectively diluting Latino political power. The proposed Senate District 32 encompasses Belmont, a neighborhood with growing Latino population, and couples it with the census tracts in the East Bronx where there is a minority of Latinos compared to other ethnicities. While the Latino community works to organize for better representation, considering that a Latino has never held a statewide elected position, it is detrimental to our progress to divide Latino communities in the one borough where we have a plurality. By grouping the west side of the Bronx with neighborhoods in Upper Manhattan and the Bronx in District 31, Bronx Latinos will compete with the needs of a more diverse and rapidly gentrifying Manhattan neighborhood and be disconnected from their neighbors to their east in their own borough. Splitting up the communities in the West Bronx where eviction rates are the highest, incomes are the lowest, and many constituents face additional hurdles due to their immigration status will only disenfranchise my neighbors further.

In census tracts across the West Bronx where Latino residents are the most common and make up at least 50% and often more than 70% of residents, state senate lines for proposed districts 31, 32, 33 and 34 by the special master carve up these neighborhoods. In each Senate district, Latino neighborhoods are divvied up and grouped with neighborhoods that have less than 50% Latino representation, forcing Latino New Yorkers to compete with their non Latino counterparts amidst a political landscape where they are already underrepresented across city and state leadership positions. While these Senate districts are not as distinguishable by partisan lean, they are dramatically different when considering low-income Latinos and communities of color are rapidly growing in the West Bronx as one of the only places to find rent-regulated apartments for working class families, largely immigrants. Grouping this community with neighborhoods that have more resources will impede the West Bronx neighborhoods from adequate representation to address our needs. We should not concentrate the electoral power of middle-income constituents in Senate District 31 while effectively disenfranchising low-income Bronxites in University Heights and Kingsbridge Heights who deserve to see their electoral power grow.

I am profoundly disappointed that the Special Master's draft maps are so deeply disrespectful to the power we're building for Latinos in New York and for the power the Bronx has been building for all of the communities we represent. These proposals as they currently stand would have a negative impact on the future of the neighborhoods I serve. The Bronx is vast, diverse, and must be empowered.

Therefore, it is in the interest of our State that the core of our current districts remain intact or close to their current form. Our borough deserves a redistricting proposal that strengthens community representation, not one that cedes our power.
