I am writing in response to the draft Congressional map released earlier this week. I am a resident of Columbia County, and the proposed changes would have disastrous consequences for our county. If allowed to stand, Columbia County would be separated from both the Capital District and the Mid-Hudson Valley regions, as well as its county neighbors to the north and south. The proposed map groups our county with Southern Tier and Finger Lakes counties, with which it has no commonality or relationship. This is unprecedented and would result in a poor outcome for our county when it comes to identity, representation, and allocation of resources.

Columbia County is located along the Hudson River in the Mid-Hudson Valley, and the Department of Economic Development has placed Columbia County in the Capital District. Under the proposed map, Columbia County would be isolated from both regions and be the only county in CD19 on the east side of the Hudson River. Columbia County should be part of a contiguous district of adjoining Mid-Hudson Valley counties. Based on current 2020 Census data, the combined populations of Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties would be 748,393 people, which is within the range of +/- 10 percent of the average congressional district.

Columbia County has been excised from its peers and placed in a congressional district that shares little in common administratively. Our judicial, assembly, and senate districts have little, if any, overlap with other counties included in the proposed CD19. Effective government requires coordination and collaboration. The proposed map diminishes Columbia County's political power.

Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties have a common history, developing major agricultural and industrial centers because of their proximity to the Hudson River. There is no such common history with counties located in the middle and western portions of New York State.

The five County Seat Cities of Hudson, Poughkeepsie, Troy, Kingston, and Catskill had a similar rise as major industrial cities that suffered steep economic declines in the first half of the 20th century but are now experiencing a great resurgence. These small to medium sized cities have diverse racial, ethnic, religious, cultural, socio-economic, and gender/sexual orientation populations. These cities have higher poverty levels than the surrounding countryside and have similar challenges to meet the need for infrastructure, broadband, workforce housing, and healthcare throughout the counties. Columbia County should be in a congressional district with its neighbors who face the same challenges and concerns.

Our proximity to New York City has created a rich, year-round arts community, with many artists, painters, dancers, musicians, actors, galleries, and antique stores that all create a destination for tourism. There is a significant and growing population of New York City dual homeowners. Newer residents are starting local small businesses, adding to the economic diversity in our county. Columbia County is also home to many exurban communities of Albany, not lthaca or Binghamton. Columbia County is tethered economically, culturally and socially to its neighbors to the north and south. The proposed map ignores these connections, and in doing so, denied our county of effective representation.

Please preserve Columbia County as a unified community of interest with our neighboring counties. We share similar agricultural, historic, artistic, and economic challenges and opportunities with Dutchess, Ulster, Rensselaer, and Greene

Congressional District 7 is a primarily Latino district drawn to connect the largest Latino communities in the Brooklyn area. The communities of Sunset Park, the Lower East Side,

and North Brooklyn. Based on the maps as they are drawn, Southwest Brooklyn is completely cutoff from rest of the community and rather than keeping the communities of interest together, the map as drawn breaks up another community of interest – black communities – by bringing Fort Greene and Clinton Hill. Further, the areas of Sunset Park and Red Hook are no longer connected to adjacent neighborhoods and communities to the north. Instead, they are placed in a district 11 that shares no commonality.

These communities of interest, while not compact, reflect the requirements of the Voting Rights Act (VRA) to keep these neighborhoods and communities of interest together. They have been united for over 30 years and now the map as drawn completely disregards and disempowers these communities.

The definition of a community of interest as specified on the NY Independent Resdistricting Committee is as follows:

A community of interest is a population which shares enough social and economic interests of importance that suggest said community should be included in a single district for effective and fair representation. These might include similar standards of living, shared methods and patterns of transportation, or similar economic and societal concerns. For example, the population of a rural area might have different shared interests from those living in an urban area, as might those living in an industrial area

from the priorities shared by those living in a primarily agricultural area. That definition encompasses exactly what community groups and individuals have raised during testimony and comments throughout this entire process. Minority communities share have shared the cultural and social dynamics of seeking to empower their respective communities, protecting their communities from a rise in hate and rhetoric, embrace the immigrant experience, and promoting the concerns related to climate change and violence on their communities. During the process, community members from across the district urged the commission to keep these neighborhoods united. Yet, the Special Master has sacrificed the empowerment of minority communities whether Latino, black, or Asian - that are culturally linked in favor of compactness and competitiveness. While the compactness of the map looks clean, it continues the historical disenfranchisement of communities of color. Sadly, this comes shortly after 10 people were killed in Buffalo in a largely Black community because the attacker believed a racist replacement theory. The proposed map is a product of a racially flawed interpretation of prioritizing compactness over voting rights. The consideration for

compactness is to do it as "practicable" and shouldn't override the primary consideration of drawing lines fair to minority voting rights.

This proposed map is simply unconstitutional and ignores the coalition of communities that have been recognized by courts and placed in the same congressional districts. Continuing to keep the Chinatowns of Lower Manhattan and Sunset Park, and their surrounding Latino communities united with North Brooklyn is especially important. In

To Whom It May Concern: I am writing in response to the draft Congressional map released earlier this week. I am a resident of Columbia County, and the proposed changes would have disastrous consequences for our county. If allowed to stand, Columbia County would be separated from both the Capital District and the Mid-Hudson Valley regions, as well as its county neighbors to the north and south. The proposed map groups our county with Southern Tier and Finger Lakes counties, with which it has no commonality or relationship. This is unprecedented and would result in a poor outcome for our county when it comes to identity, representation, and allocation of resources. Columbia County is located along the Hudson River in the Mid-Hudson Valley, and the Department of Economic Development has placed Columbia County in the Capital District. Under the proposed map, Columbia County would be isolated from both regions and be the only county in CD19 on the east side of the Hudson River. Columbia County should be part of a contiguous district of adjoining Mid-Hudson Valley counties. Based on current 2020 Census data, the combined populations of Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties would be 748,393 people, which is within the range of +/-10 percent of the average congressional district. Columbia County has been excised from its peers and placed in a congressional district that shares little in common administratively. Our judicial, assembly, and senate districts have little, if any, overlap with other counties included in the proposed CD19. Effective government requires coordination and collaboration. The proposed map diminishes Columbia County's political power. Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties have a common history, developing major agricultural and industrial centers because of their proximity to the Hudson River. There is no such common history with counties located in the middle and western portions of New York State. The five County Seat Cities of Hudson, Poughkeepsie, Troy, Kingston, and Catskill had a similar rise as major industrial cities that suffered steep economic declines in the first half of the 20th century but are now experiencing a great resurgence. These small to medium sized cities have diverse racial, ethnic, religious, cultural, socio-economic, and gender/sexual orientation populations. These cities have higher poverty levels than the surrounding countryside and have similar challenges to meet the need for infrastructure, broadband, workforce housing, and healthcare throughout the counties. Columbia County should be in a congressional district with its neighbors who face the same challenges and concerns. Our proximity to New York City has created a rich, year-round arts community, with many artists, painters, dancers, musicians, actors, galleries, and antique stores that all create a destination for tourism. There is a significant and growing population of New York City dual homeowners. Newer residents are starting local small businesses, adding to the economic diversity in our county. Columbia County is also home to many exurban communities of Albany, not Ithaca or Binghamton. Columbia County is tethered economically, culturally and socially to its neighbors to the north and south. The proposed map ignores these connections, and in doing so, denied our county of effective representation. Please preserve Columbia County as a unified community of interest with our neighboring counties. We share similar agricultural, historic, artistic, and economic challenges and opportunities with Dutchess, Ulster, Rensselaer, and Greene Counties as part of the Mid-Hudson Valley region. Dividing Columbia County, or separating us from the Mid-Hudson Valley region, would seriously impact the residents who want to build for the future and be fairly represented in Congress. It would be a gross miscarriage of justice that will have long-term adverse consequences for our residents and our region if these district lines are allowed to stand. The removal of the entire block between West <sup>111th</sup> Street and West <sup>112th</sup> Street from 5<sup>th</sup> Avenue to Malcolm X Boulevard from District 30—raises great concern for my community and me. The Public School located on this block, P.S. 185—The Locke School Of Arts & Engineering is an integral part of the fabric of SD-30. It has historically served as a poll site and moreover, is a District 3 School. The District 3 catchment area contains Harlem and the Upper West Side, thus the placement of P.S. 185 within proposed SD-29, which has no other District 3 schools within it, has the potential to marginalize and dilute representation as well as affect funding and resoruces. In addition, students to the south, west and north of this block will be zoned for this school but not represented by a Senator who represents the District 3 zoned area.

To Whom It May Concern:

I am writing in response to the draft Congressional map released earlier this week. I am a resident of Columbia County, and the proposed changes would have disastrous consequences for our county. If allowed to stand, Columbia County would be separated from both the Capital District and the Mid-Hudson Valley regions, as well as its county neighbors to the north and south. The proposed map groups our county with Southern Tier and Finger Lakes counties, with which it has no commonality or relationship. This is unprecedented and would result in a poor outcome for our county when it comes to identity, representation, and allocation of resources.

Columbia County is located along the Hudson River in the Mid-Hudson Valley, and the Department of Economic Development has placed Columbia County in the Capital District. Under the proposed map, Columbia County would be isolated from both regions and be the only county in CD19 on the east side of the Hudson River. Columbia County should be part of a contiguous district of adjoining Mid-Hudson Valley counties. Based on current 2020 Census data, the combined populations of Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties would be 748,393 people, which is within the range of +/- 10 percent of the average congressional district.

Columbia County has been excised from its peers and placed in a congressional district that shares little in common administratively. Our judicial, assembly, and senate districts have little, if any, overlap with other counties included in the proposed CD19. Effective government requires coordination and collaboration. The proposed map diminishes Columbia County's political power.

Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties have a common history, developing major agricultural and industrial centers because of their proximity to the Hudson River. There is no such common history with counties located in the middle and western portions of New York State.

The five County Seat Cities of Hudson, Poughkeepsie, Troy, Kingston, and Catskill had a similar rise as major industrial cities that suffered steep economic declines in the first half of the 20th century but are now experiencing a great resurgence. These small to medium sized cities have diverse racial, ethnic, religious, cultural, socio-economic, and gender/sexual orientation populations. These cities have higher poverty levels than the surrounding countryside and have similar challenges to meet the need for infrastructure, broadband, workforce housing, and healthcare throughout the counties. Columbia County should be in a congressional district with its neighbors who face the same challenges and concerns.

Our proximity to New York City has created a rich, year-round arts community, with many artists, painters, dancers, musicians, actors, galleries, and antique stores that all create a destination for tourism. There is a significant and growing population of New York City dual homeowners. Newer residents are starting local small businesses, adding to the economic diversity in our county. Columbia County is also home to many exurban communities of Albany, not Ithaca or Binghamton. Columbia County is tethered economically, culturally and socially to its neighbors to the north and south. The proposed map ignores these connections, and in doing so, denied our county of effective representation.

Please preserve Columbia County as a unified community of interest with our neighboring counties. We share similar agricultural, historic, artistic, and economic challenges and opportunities with Dutchess, Ulster, Rensselaer, and Greene

I am writing to you regarding the proposed change to the state Senate district map for my block (Bergen Street between 4<sup>th</sup> and 5<sup>th</sup> Avenues) in Brooklyn. We have lived here since 1990, and raised two kids who went to local schools and now also live nearby.

I am concerned that the proposed removal of our blocks from the neighborhood to which they are part of will, effectively, disenfranchise us. To add these few blocks of Park Slope (south of Flatbush Avenue bordered by Warren Street, Prospect Place, and 4<sup>th</sup> Avenue) to a much larger district on the other side of Flatbush, subverts our ability to make the case for our local concerns, which include street parking (now used by patrons of the state-enabled Barclay's arena), speeding, honking, transit, lack of open space, no dog-runs, development on 4<sup>th</sup> Avenue, the changes in retail, restaurants, and bars on our "main street" (5<sup>th</sup> Avenue, which terminates at Flatbush) and many other quality of life issues.

All these issues are shared with Park Slope and Boerum Hill; the central core of our neighborhood is to the south and west, not across Flatbush.

The original singular Northwest Bronx State Senate district which included neighborhoods working together to advocate for shared needs are now divided and marginalized with other communities. University Heights and Kingsbridge Heights neighborhoods are now pushed out to District 31 with areas of Manhattan. The Fordham neighborhood is now in District 32. The Crotona and southern part of Belmont neighborhoods are in District 33 and Tremont/Burnside and Jerome neighborhoods are in two different districts. All of these neighborhoods are serviced by our organizations, have experienced a shared history and have been working together for a long time to address issues impacting our areas.

We appreciate the challenges of developing a map that is fair, that is consistent with communities of interest and that recognizes economic development needs and realities. Unfortunately for Cayuga County, these maps fail. We applaud that you have been able to keep the City of Auburn within the same State Senate and Congressional districts. This will be of value for the City of Auburn but the benefit ends there.

Cayuga County and Auburn are integrally tied to Syracuse and Onondaga County in every way that matters: jobs and economic development; cultural and social activities; and health services, to name a few. Similarly, every county west of Cayuga County reasonably looks west to Monroe County for similar resources. In the drawn map, we are isolated from the heart of our geographic area. To remove us from both the State Senate and Congressional Districts of our economic and cultural center will put us at a disadvantage in every way that is important in the context of representation.

To Whom It May Concern:

I am writing in response to the draft Congressional map released earlier this week. I am a resident of Columbia County, and the proposed changes would have disastrous consequences for our county. If allowed to stand, Columbia County would be separated from both the Capital District and the Mid-Hudson Valley regions, as well as its county neighbors to the north and south. The proposed map groups our county with Southern Tier and Finger Lakes counties, with which it has no commonality or relationship. This is unprecedented and would result in a poor outcome for our county when it comes to identity, representation, and allocation of resources.

Columbia County is located along the Hudson River in the Mid-Hudson Valley, and the Department of Economic Development has placed Columbia County in the Capital District. Under the proposed map, Columbia County would be isolated from both regions and be the only county in CD19 on the east side of the Hudson River. Columbia County should be part of a contiguous district of adjoining Mid-Hudson Valley counties. Based on current 2020 Census data, the combined populations of Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties would be 748,393 people, which is within the range of +/- 10 percent of the average congressional district.

Columbia County has been excised from its peers and placed in a congressional district that shares little in common administratively. I am writing in response to the draft Congressional map released earlier this week. I am a resident of Columbia County, and the proposed changes would have disastrous consequences for our county. If allowed to stand, Columbia County would be separated from both the Capital District and the Mid-Hudson Valley regions, as well as its county neighbors to the north and south. The proposed map groups our county with Southern Tier and Finger Lakes counties, with which it has no commonality or relationship. This is unprecedented and would result in a poor outcome for our county when it comes to identity, representation, and allocation of resources.

Columbia County is located along the Hudson River in the Mid-Hudson Valley, and the Department of Economic Development has placed Columbia County in the Capital District. Under the proposed map, Columbia County would be isolated from both regions and be the only county in CD19 on the east side of the Hudson River. Columbia County should be part of a contiguous district of adjoining Mid-Hudson Valley counties. Based on current 2020 Census data, the combined populations of Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties would be 748,393 people, which is within the range of +/- 10 percent of the average congressional district.

The new Congressional maps introduced earlier this week seem to neglect several majority minority communities and will require many incumbents to challenge one another. For example, Representative Grace Meng, an Asian American woman, has been representing a heavily Asian American swath of Queens and she has been drawn out of her district. Representative Hakeem Jeffries, a Black man, has represented diverse neighborhoods in Brooklyn and Queens and has been drawn out of his district. Representative Nydia Velazquez, who is Latina, has been drawn out of her Latino-heavy district in Brooklyn. 

Dear Jonathan Cervas,

As a long-time resident and taxpayer of Greene County, NY, I am very upset about the newly defined redistricting map. Separating Columbia and Greene Counties is very inefficient, and neglects the history of our twin counties working together. Currently we share a hospital, community college, mental health resources, addiction recovery resources, and Cornell Cooperative Extension, to name a few. We are already a low income and high addiction county, historically in the low ranking numbers of the state in poverty, though we are rapidly growing due to the increased influx into the Hudson Valley of Upstate NY, of which Greene County is a vital part. Please reconsider this map.

Greene County is also included in the description of the Capital Region

While we are divided by the Hudson River, we share the responsibility for the estuaries and other environmental aspects of the shores of the Hudson River, even though we may not be on the same side of the Hudson.

Separating Greene County from Columbia County, the Hudson River, and Capital Region, in any capacity, is unthinkable for Greene County residents. This is a community element, as well as something distinguished in many publications, now and throughout the past. The Hudson Valley is a part of the Catskill Mountains, which is the heart of Greene County.

In 18 years of living in the village of Catskill, I have only a couple of times traveled west of Woodstock, & never in the southern parts of the newly defined district. I've never had any reason or desire to, nor driving ability, & don't want to start now!

I understand that this process to redraw maps has had to happen quickly, please do not discount the vital relationship between Columbia and Greene County, nor our relationship to the Hudson Valley and the Capital Region. This is our home, & we hope to continue to have viable lives in it!
