To Whom It May Concern:

I am writing in response to the draft Congressional map released earlier this week. I am a resident of Columbia County, and the proposed changes would have disastrous consequences for our county. If allowed to stand, Columbia County would be separated from both the Capital District and the Mid-Hudson Valley regions, as well as its county neighbors to the north and south. The proposed map groups our county with Southern Tier and Finger Lakes counties, with which it has no commonality or relationship. This is unprecedented and would result in a poor outcome for our county when it comes to identity, representation, and allocation of resources.

Columbia County is located along the Hudson River in the Mid-Hudson Valley, and the Department of Economic Development has placed Columbia County in the Capital District. Under the proposed map, Columbia County would be isolated from both regions and be the only county in CD19 on the east side of the Hudson River. Columbia County should be part of a contiguous district of adjoining Mid-Hudson Valley counties. Based on current 2020 Census data, the combined populations of Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties would be 748,393 people, which is within the range of +/- 10 percent of the average congressional district.

Columbia County has been excised from its peers and placed in a congressional district that shares little in common administratively. Our judicial, assembly, and senate districts have little, if any, overlap with other counties included in the proposed CD19. Effective government requires coordination and collaboration. The proposed map diminishes Columbia County's political power.

Columbia, Dutchess, Rensselaer, Ulster, and Greene Counties have a common history, developing major agricultural and industrial centers because of their proximity to the Hudson River. There is no such common history with counties located in the middle and western portions of New York State.

The five County Seat Cities of Hudson, Poughkeepsie, Troy, Kingston, and Catskill had a similar rise as major industrial cities that suffered steep economic declines in the first half of the 20th century but are now experiencing a great resurgence. These small to medium sized cities have diverse racial, ethnic, religious, cultural, socio-economic, and gender/sexual orientation populations. These cities have higher poverty levels than the surrounding countryside and have similar challenges to meet the need for infrastructure, broadband, workforce housing, and healthcare throughout the counties. Columbia County should be in a congressional district with its neighbors who face the same challenges and concerns.

Our proximity to New York City has created a rich, year-round arts community, with many artists, painters, dancers, musicians, actors, galleries, and antique stores that all create a destination for tourism. There is a significant and growing population of New York City dual homeowners. Newer residents are starting local small businesses, adding to the economic diversity in our county. Columbia County is also home to many exurban communities of Albany, not Ithaca or Binghamton. Columbia County is tethered economically, culturally and socially to its neighbors to the north and south. The proposed map ignores these connections, and in doing so, denied our county of effective representation.

Please preserve Columbia County as a unified community of interest with our neighboring counties. We share similar agricultural, historic, artistic, and economic challenges and opportunities with Dutchess, Ulster, Rensselaer, and Greene

Counties as part of the Mid-Hudson Valley region. Dividing Columbia County, or separating us from the Mid-Hudson Valley region, would seriously impact the residents who want to build for the future and be fairly represented in Congress. It would be a gross miscarriage of justice that will have long-term adverse consequences for our residents and our region if these district lines are allowed to stand. We urge you to correct this grave mistake.

As a faith-based community leader, I am reaching out on behalf of my congregation at the South Hempstead Baptist Church and as the moderator of the Eastern Baptist Association Inc. which represents the commonly aligned communities of Westbury, Hempstead, Uniondale, Roosevelt, Lakeview.

Long Island's demographics have notably changed in past decades, to the point at which Nassau County's population is now just barely majority non-Hispanic white. This calls for a rethinking of its congressional districts.

We note that the Special Master's proposed map embraces this demographic reality, as it divides southwest Nassau County from Queens (in the Elmont and Valley Stream areas included in the current Fifth District). In this spirit, we urge consideration of additional remedies of a marginal but significant nature, remedies that are notably rooted in the Fourth District's historical composition.

Historically, in addition to portions of the Town of Hempstead, the Fourth Congressional District has included portions of the Town of North Hempstead, specifically majority-minority Westbury and New Cassel, in addition to Mineola. Our map continues this tradition, and we wish to highlight that Jericho Turnpike (particularly east of Northern State Parkway) rather than the town line represents a substantial dividing line by race, income, and population density. This may not be readily apparent considering Eisenhower Park's placement, yet any quick study of demographics (or view of Jericho

Turnpike on GoogleMaps aerial view) confirms this social connectivity between Westbury/New Cassel and majority-minority communities located in the Town of Hempstead, such as Freeport, the Village of Hempstead, Valley Stream, and Elmont.

Some may contend that it is vital to maintain town boundaries in Nassau County. While this is one factor, the long-established social connectivity between Nassau County's communities of color -- who differ in lived experience and voting behavior from their white counterparts -- justifies consideration of an even more important one: the ability for minority voters to elect a candidate of their choice. As the Special Master's division of southwest Nassau County from Queens underscores this opportunity, the addition of Westbury and New Cassel further enhances the ability of voters of color to elect a candidate of their choice. In addition, local legislative districts at the town and county level (such as Nassau County's Second Legislative District) share commonality with this representational theme (i.e. the Nassau County Second Legislative District contains the two majority-minority precincts in the Town of Oyster Bay's Hicksville), and are indeed mandated by litigation (*Jackson v Nassau County Board of Supervisors*, and even *Goosby v Town Board of Hempstead*).

For more specificity, our proposed district is majority-minority not only in composition (47.4% White, 23.7% Hispanic, 20.3% Black, and 8.7% Asian, versus the initial Special Master proposal, at 50.7% White, 22.1% Hispanic, 19.1% Black, and 8.2% Asian) but also in voting-age population (49.7% White, 21.8% Hispanic, 20.1% Black, and 8.4% Asian, versus the initial Special Master proposal, at 52.9% White, 20.3% Hispanic, 18.9% Black, and 7.8% Asian). This suggests a significant change from ten years ago, when our proposal was 58.2% White, 17.9% Hispanic, 19.6% Black, and 6.1% Asian in its voting-age population. Demographic trends suggest our proposed majority-minority district is becoming ever-more diverse.

You may wonder how this impacts adjacent districts. Our recommendations maintain consistency with the Special Master's map. We noted the single split between Nassau and Suffolk Counties, in contrast to the current North Shore-South Shore divide. In order to add portions of the Town of North Hempstead to the Fourth, we have added portions of the Town of Hempstead culturally, politically, and demographically similar to adjacent sections of the Town of Oyster Bay, namely Seaford, Wantagh, and North Wantagh (compare to Massapequa and Massapequa Park on the Town of Oyster Bay side) in addition to Levittown as the Special Master had done.

In conclusion, we urge for the adoption of this proposed iteration of the Fourth Congressional District.

Dear Judge McAllister and Special Master Cervas:

I am a long-time resident of Brooklyn Heights and a retired New York State Workers' Compensation Law Judge. I have long been active in supporting local representatives, particularly our Assembly representative, Congressional representative and New York State Senator, to preserve and improve our neighborhoods, including protection, repair, and preservation of portions of the Brooklyn-Queens Expressway and Brooklyn Heights Promenade abutting many of our communities.

I have long been proud of the community of interest my neighborhood has long had with the communities of Dumbo, Cobble Hill, Carroll Gardens, Boerum Hill, Park Slope, Gowanus, Red Hook and Sunset Park. We have long acted together with mutual support in countless ways including in jointly presenting for election members of the county committee, judicial delegates, and judicial alternates, all of whom now face risks of being disenfranchised by the current recently created changes in district lines as well as lines for representatives of Congress and the New York Senate.

I respectfully ask you to reconsider the current drawing of the Congressional and State Senate District lines which would break apart our long-held communities of interest, most particularly those of Brooklyn Heights, Gowanus, Red Hook and Sunset Park.

I also ask you to re-consider drawing of the borders of the southwest corner of the proposed Senate District 25, namely the triangular area bordered by Flatbush Avenue, Warren Street/Prospect Place, and 4th Avenue in Brooklyn. This portion of the proposed Senate District explicitly separates that triangular area from the rest of the neighborhood of Park Slope, residents of all of which have similarly long held a deeply held community of interest.


The New York Constitution, Art II, Section 4, Subdivision (c)((5) prescribes that in drawing legislative boundaries, consideration shall be given to "maintenance of cores of existing districts, of pre-existing political subdivisions, including counties, cities, and towns, and of communities of interest."

I respectfully submit that the boundaries set forth in the most recently created district map fails to comply with the foregoing prescription.

I note also that contrary to the direction in the same subdivision that districts "shall not be drawn to discourage competition or for the purpose of favoring or disfavoring incumbents or other particular candidates of political parties," the recently created boundary map does exactly that. It effectively causes incumbent members of Congress of the same political party, one of whom formerly represented parts of Manhattan and Brooklyn, and candidates of the same party and community of interest for the State Senate in Brooklyn Heights and Bay Ridge of Brooklyn to oppose each other on the ballot.

Some may contend that it is vital to maintain town boundaries in Nassau County. While this is one factor, the long-established social connectivity between Nassau County's communities of color -- who differ in lived experience and voting behavior from their white counterparts -- justifies consideration of an even more important one: the ability for minority voters to elect a candidate of their choice. As the Special Master's division of southwest Nassau County from Queens underscores this opportunity, the addition of Westbury and New Cassel further enhances the ability of voters of color to elect a candidate of their choice. In order to add portions of the Town of North Hempstead to the Fourth, we have added portions of the Town of Hempstead culturally, politically, and demographically similar to adjacent sections of the Town of Oyster Bay, namely Seaford, Wantagh, and North Wantagh (compare to Massapequa and Massapequa Park on the Town of Oyster Bay side) in addition to Levittown as the Special Master had done.

I am Leslie Davis, President of the Westbury/ New-Cassel Chapter of the NAACP. The Westbury, New Cassel chapter of the NAACP is filing a petition opposing the proposed New York Congressional districts, specifically the proposed lines of Congressional District 4. Long Island's demographics have notably changed in past decades, to the point at which Nassau County's population is now just barely majority non-Hispanic white. This calls for a rethinking of its congressional districts.

We note that the Special Master's proposed map embraces this demographic reality, as it divides southwest Nassau County from Queens (in the Elmont and Valley Stream areas included in the current Fifth District). In this spirit, we urge consideration of additional remedies of a marginal but significant nature, remedies that are notably rooted in the Fourth District's historical composition.

Historically, in addition to portions of the Town of Hempstead, the Fourth Congressional District has included portions of the Town of North Hempstead, specifically majority-minority Westbury and New Cassel, in addition to Mineola. Our map continues this tradition, and we wish to highlight that Jericho Turnpike (particularly east of Northern State Parkway) rather than the town line represents a substantial dividing line by race, income, and population density. 




As members of the community, we are deeply disappointed by the map proposed on Monday, May 16th, for the 8th and 9th congressional districts of New York.

This draft map inexplicably dilutes the Black population in the 8th and 9th congressional districts in a manner wildly inconsistent with the constitutional mandate that communities of color should be put into a position to elect the candidate of their choice. The 8th district, as it is currently drawn, allows Fort Greene to join forces with other predominantly black neighborhoods like Clinton Hill, Bedford-Stuyvesant, Ocean Hill, Brownsville, East New York and Canarsie. These communities, along with our neighbors on the coastline of Jamaica Bay, have been able to speak with a unified voice to advocate for our common interests, issues and needs. The 9th District, as it is drawn cracks Bedford Stuyvesant and splits Crown Heights. How do you explain the dilution of the voices that once joined together to address issues, needs and concerns in the neighborhoods within this district?

The Court in Steuben County, which is more than 250 miles from our community, should have taken into account the comprehensive testimony of Brooklyn residents, civic leaders and stakeholders who made it clear that the communities of interest that presently constitute the 8th and 9th congressional districts should be kept together, as was the case in maps submitted by good government groups like Common Cause, civil rights groups like the Unity Coalition and the Independent Redistricting Commission (IRC).

We fervently oppose these draft maps and urge you to reconsider. Please make the communities of Crown Heights, Clinton Hill and Bedford Stuyvesant whole again. Please reference the Maps that were drawn by the Unity Map Coalition and supported by the National Association for the Advancement of Colored People. These maps take into consideration the feedback of a diverse coalition and accurately reflect how the final maps should be redrawn.



I am Leslie Davis, President of the Westbury/ New-Cassel Chapter of the NAACP. The Westbury, New Cassel chapter of the NAACP is filing a petition opposing the proposed New York Congressional districts, specifically the proposed lines of Congressional District 4. Long Island's demographics have notably changed in past decades, to the point at which Nassau County's population is now just barely majority non-Hispanic white. This calls for a rethinking of its congressional districts.

We note that the Special Master's proposed map embraces this demographic reality, as it divides southwest Nassau County from Queens (in the Elmont and Valley Stream areas included in the current Fifth District). In this spirit, we urge consideration of additional remedies of a marginal but significant nature, remedies that are notably rooted in the Fourth District's historical composition.

Historically, in addition to portions of the Town of Hempstead, the Fourth Congressional District has included portions of the Town of North Hempstead, specifically majority-minority Westbury and New Cassel, in addition to Mineola. Our map continues this tradition, and we wish to highlight that Jericho Turnpike (particularly east of Northern State Parkway) rather than the town line represents a substantial dividing line by race, income, and population density. This may not be readily apparent considering Eisenhower Park's placement, yet any quick study of demographics (or view of Jericho Turnpike on GoogleMaps aerial view) confirms this social connectivity between Westbury/New Cassel and majority-minority communities located in the Town of Hempstead, such as Freeport, the Village of Hempstead, Valley Stream, and Elmont.

Some may contend that it is vital to maintain town boundaries in Nassau County. While this is one factor, the long-established social connectivity between Nassau County's communities of color -- who differ in lived experience and voting behavior from their white counterparts -- justifies consideration of an even more important one: the ability for minority voters to elect a candidate of their choice. As the Special Master's division of southwest Nassau County from Queens underscores this opportunity, the addition of Westbury and New Cassel further enhances the ability of voters of color to elect a candidate of their choice. In addition, local legislative districts at the town and county level (such as Nassau County's Second Legislative District) share commonality with this

representational theme (i.e. the Nassau County Second Legislative District contains the two majority-minority precincts in the Town of Oyster Bay's Hicksville), and are indeed mandated by litigation (*Jackson v Nassau County Board of Supervisors*, and even *Goosby v Town Board of Hempstead*).

For more specificity, our proposed district is majority-minority not only in composition (47.4% White, 23.7% Hispanic, 20.3% Black, and 8.7% Asian, versus the initial Special Master proposal, at 50.7% White, 22.1% Hispanic, 19.1% Black, and 8.2% Asian) but also in voting-age population (49.7% White, 21.8% Hispanic, 20.1% Black, and 8.4% Asian, versus the initial Special Master proposal, at 52.9% White, 20.3% Hispanic, 18.9% Black, and 7.8% Asian). This suggests a significant change from ten years ago, when our proposal was 58.2% White, 17.9% Hispanic, 19.6% Black, and 6.1% Asian in its voting-age population. Demographic trends suggest our proposed majority-minority district is becoming ever-more diverse.

You may wonder how this impacts adjacent districts. Our recommendations maintain consistency with the Special Master's map. We noted the single split between Nassau and Suffolk Counties, in contrast to the current North Shore-South Shore divide. In order to add portions of the Town of North Hempstead to the Fourth, we have added portions of the Town of Hempstead culturally, politically, and demographically similar to adjacent sections of the Town of Oyster Bay, namely Seaford, Wantagh, and North Wantagh (compare to Massapequa and Massapequa Park on the Town of Oyster Bay side) in addition to Levittown as the Special Master had done.

In conclusion, we urge for the adoption of this proposed iteration of the Fourth Congressional District.

Dear Judge McAllister and Dr. Cervas,

Congressional District 7 has been, for the past 3 decades, a district where Latino and Asian voters can elect a candidate of choice, empowering communities that in the past were divided and whose voices were diluted. These communities of interest, while not compact, were united to reflect the requirements of the Voting Rights Act (VRA) to keep these neighborhoods and communities of interest together. The special master's map as drawn completely disregards and disempowers these communities—a shocking insult in the face of the incredible growth of Latino and Asian New Yorkers, and a startling threat to these communities in the face of a VRA that remains on the books as federal law.

This Congressional District's cohesion has been noted by court after court after court—not for partisan purposes, but for legal necessities that are underscored by civil rights principles.

The district was drawn to connect the largest Latino communities from North Brooklyn to the Lower East Side across the bridge and Sunset Park to the south. Additionally, the court upheld the Asian community of interest between the two Chinatowns linked from Manhattan to Southwest Brooklyn along the N/R subway lines. Based on the maps as they are drawn, Southwest Brooklyn is completely cut off. Further, the areas of Sunset Park and Red Hook are no longer connected to adjacent neighborhoods and communities to the north and placed in a district that shares no commonality. Already marginalized from transit and split in political districts, Red Hook and Sunset Park are divided and not united in the current proposal. The maps also unfairly chop up and pit neighboring Black voting rights district Representatives both in Brooklyn and in the Bronx and Westchester.

The definition of a community of interest as specified on the NY Independent Redistricting Committee is as follows:

A community of interest is a population which shares enough social and economic interests of importance that suggest said community should be included in a single district for effective and fair representation. These might include similar standards of living, shared methods and patterns of transportation, or similar economic and societal concerns.

That definition encompasses exactly what community groups and individuals have raised during testimony and comments throughout this entire process. This is NOT partisanship at play, it's common sense and civil rights. Communities of color share cultural and social dynamics and have worked to empower their respective communities, protect their members from a rise in hate, embrace the immigrant experience, and promote climate and environmental justice. During the entire years-long process, community members from across the 7th Congressional District urged the commission to keep these neighborhoods united.

Yet, the Special Master has sacrificed the empowerment of minority communities – whether Latino, Black, or Asian – that are culturally linked in favor of compactness and competitiveness. Compactness has less weight in an urban area built on islands connected by bridges and transit lines. While the maps may look “clean”, they exacerbate the historical disenfranchisement of communities of color. The proposed map is a product of a racially flawed interpretation of prioritizing compactness over voting rights. The consideration for compactness is to do it as “practicable” and shouldn't override the primary consideration of drawing lines fair to minority voting rights.

Let's be clear—this proposed map is unconstitutional on a state and federal level. It degrades the Latino population, depriving voters of fair representation by ripping apart 5 neighborhoods that have been a core part of the district for nearly 30 years. It ignores the coalition of communities that have been recognized by courts and placed in the same congressional districts. And it ignores the hundreds of people who took time out of their busy schedules to testify.

Continuing to keep the Chinatowns of Lower Manhattan and Sunset Park, and their surrounding Latino communities united with North Brooklyn is especially important. In fact, keeping Sunset Park tied to its roots and that of its communities of interest together was one item that had bipartisan support within the commission. To see that changed by the Special Master is shameful. The map as drawn will have dire impacts on the communities, particularly Latinos who represent nearly 1 in 5 New Yorkers but lack meaningful representation across the entire state. The map should reflect their right to ensure access to candidates that represent their community's interests and needs. Fairness, not compactness, should be at the heart of this redistricting process.

Therefore, I sincerely urge the map to be redrawn to keep these communities together.

New York City is a melting pot of different cultures and ethnicities. Any intention of “redistricting” should be an attempt to create a fair, favorable, and equitable environment for its constituents. These maps come off as an effort to dilute minority representation amongst “specific” public officials. I hope that Mr. Cervas make his findings public– on how these lines were derived and how much time [if any] was spent in the state of New York when he crafted his module? It would be very concerning if most of the general decision-making was used off the basis of available data such as demographic information instead of ground site visits.

Furthermore, these maps show several incumbents who may now be forced to relocate due to their current status outside of city lines. These members were favorably elected to represent an area they feel comfortable in. However, poised with possible relocation costs and the potential shifts in public policy that will reflect the area’s needs, you are creating a less than authentic experience for both the voters and candidates seeking to run for office. Such a dynamic shift could upend previous progress made for all communities.

These are just but a few concerns that could, in turn, create lasting consequences. More time and consideration should be the alternative, and an exploratory committee should be afforded to Mr. Cervas so that he may more accurately draw lines that encapsulate all of the things that make New York one of the most diverse states in the nation.

As representatives and members of the clergy in Central Brooklyn, we write to you to today to express our deep concern with the newly drawn 8th Congressional District of New York and to provide testimony outlining the consequences this new map will have on both our communities of faith all of those who reside in this historic district.

Long before the Voting Rights Act of 1965 was established allowing so many communities of interest to have representation, Central Brooklyn, including the great neighborhood of Bedford–Stuyvesant, has always been home to a strong and diverse community of faith with some of our historic Black churches dating back to before the Civil War. Generations of hard working African American families have been linked together by many of the same churches and religious centers that still exist presently. Today, so many of us still work together, eat together, pray together, and serve our community together.

The deep-rooted generational bond that ties the tenets of this community together in Central Brooklyn has strengthened our resolve and driven many of us towards a shared purpose to help one another and fight for the same causes. We are, by definition, a community of interest. Together, the congregations here work collectively to grow our community stronger and address common problems like the historic inequities many of us in the Black community have lived with our whole lives. By working together, tackling similar concerns, and creating meaningful partnerships with our community, we have been able to achieve so much.

Much of our success, however, has been a direct result of our ability to speak collectively to our shared federal representative. Our leverage is in our unified voice, but the newly drawn 8th Congressional District of New York threatens to undermine and potentially eliminate that power. With these new lines, Bedford-Stuyvesant has been cracked in half, ripping the “flock,” which many consider to be the beating heart of Bedford-Stuyvesant, in half as well.

Preserving the believers in Central Brooklyn under one congressional district is to preserve our common mission to stay

connected and advocate for our shared interests. The newly created map dilutes our voice and consequentially, diminishes our ability to fight for what we believe is right.

On behalf of all parishioners in Central Brooklyn, we ask that you consider what this new map does to our voice. The New York State Constitution requires the core of existing congressional districts be protected. We humbly state that the communities of faith in Central Brooklyn represent a core part of this district and ask you to keep us intact so that we may continue to serve this great district together.



There are two areas of the map that I believe contain unnecessary splitting of communities of interest, and could better be resolved: the Buffalo suburbs, and south Brooklyn.

Buffalo

The current draft splits Erie County 3 ways, and places the city of Buffalo itself in with Niagara County, much of which is fully rural and bears little relation or political history with the city. Meanwhile, doing so places inner suburbs, places where the typical resident commutes into the city, shops there, etc. This is especially concerning in the case of Cheektowaga and Lackawanna, as it splits off some of Buffalo's Black and Latino communities.


To fix this, I propose that every inner suburb abutting the city be returned to the Buffalo district: Cheektowaga, West Seneca, and Lackawanna. To resolve the three-way splitting of Erie and the lost population for the Southern Tier district, shift Tioga County into it (which would, incidentally, do a better job at keeping the Southern Tier together). This gives almost perfect population equality. The Buffalo district can then transfer away its rural population to the Finger Lakes district. The tweaks after that are less important, but my suggestion to achieve population equity from there is giving the 19th district the rest of Otsego and Schoharie counties, then have the North Country district make up the remainder in Jefferson County, which is already split. I also think this configuration would be better served if the Rochester district went into Wayne instead of Orleans, for reasons of compactness. The below image shows this all visually.



Brooklyn

My main suggestion is that the Asian communities of South Brooklyn not undergo a 4-way split. I also think it would be helpful, especially for later in the decade as Brooklyn gentrifies, to increase the Black share in CD-9. To fix this, I suggest not extending CD-9 as far south, and giving it everything west of Flatbush Ave. Make up the population difference by giving the 9th the rest of Bed-Stuy, while the 8th can move further into South Brooklyn, while also losing its share of Bensonhurst, which should go, as with the southern end of CD-9, to CD-11. Borough Park should be moved to CD-9 to help it function as a district selecting Black voters' choice, since the residents there are unlikely to bloc vote with the

more liberal voters in the north of the district. For reasons of population equality, CD-10 then needs to take the rest of Red Hook, Sunset Park, and a little bit more. I would suggest some of north Bensonhurst, since Bay Ridge is directly across from Staten Island, and makes more sense in CD-11. The below image shows this all visually.

I am writing to you regarding the proposed change to the state Senate district map for my block (Bergen Street between 4th and 5th Avenues) in Brooklyn. We have lived here since 1998, and raised two daughters who went to local schools and now also live nearby.

I am concerned that the proposed removal of our blocks from the neighborhood to which they are part of will, effectively, disenfranchise us. To add these few blocks of Park Slope (south of Flatbush Avenue bordered by Warren Street, Prospect Place, and 4th Avenue) to a much larger district on the other side of Flatbush, subverts our ability to make the case for our local concerns, which include street parking (now used by patrons of the state-enabled Barclay's arena), speeding, honking, transit, lack of open space, no dog-runs, development on 4th Avenue, the changes in retail, restaurants, and bars on our "main street" (5th Avenue, which terminates at Flatbush) and many other quality of life issues.

All these issues are shared with Park Slope and Boerum Hill; the central core of our neighborhood is to the south and west, not across Flatbush.

Dear Justice McAllister and Special Master Cervas,

Gowanus Canal Conservancy (GCC) the environmental steward for the Gowanus Canal and Watershed located within the existing NY-7 Congressional District boundaries. We are dedicated to facilitating the development of a resilient, vibrant, open space network centered on the Gowanus Canal through activating and empowering community stewardship of the Gowanus Watershed. Since 2006, we have served as the environmental steward for the neighborhood through leading grassroots volunteer projects; educating students on environmental issues; and working with agencies, elected officials, and the community to advocate for, build, and maintain innovative green infrastructure to mitigate the impacts of Combined Sewage Overflow (CSO) and support improved water quality of the Gowanus Canal.

The Gowanus Canal is one of the dirtiest waterbodies in the country, due to a combination of historic industrial contamination and ongoing combined sewage overflow. Largely due to the committed advocacy of a single Congresswoman for the existing NY-7 district, the EPA is currently overseeing a comprehensive Superfund clean-up to address this contamination. However, the proposed Congressional redistricting cuts a major portion of the canal, flowing between Red Hook and Sunset Park, out of district NY-7, endangering the years of planning and advocacy for a comprehensive clean-up.

Additionally, while the proposed map does include much of the Gowanus Canal and Watershed, it excludes the southern reaches of the Canal that extend into Gowanus Bay and ignores the hydrologic connections between the neighborhoods of Gowanus and Red Hook. The boundary of NY-7 must be extended to include Red Hook to ensure comprehensive planning that will continue to address water quality and flooding due to increased precipitation and the impacts of climate change,
