COMES NOW the Defendant, the City of Virginia Beach (“City”), by counsel, and hereby files its Motion to Dismiss Plaintiff’s claims pursuant to Rule 12(b)(6) of the Federal Rules of Civil Procedure on the grounds that Plaintiff’s Complaint fails to state a claim against the City upon which relief may be granted. The reasons and legal authorities supporting this Motion are fully set forth in the accompanying Memorandum of Law filed herewith.

WHEREFORE, the City respectfully moves this Court to enter an Order granting this Motion and dismiss Plaintiff’s Complaint against the City with prejudice, and for all such other and further relief as the Court deems appropriate.

Plaintiff is advised that:

- (1) A *pro se* party is entitled to file a response opposing the motion and that any such response must be filed within twenty one (21) days of the date on which the dispositive or partially dispositive motion is filed; and
- (2) The Court could dismiss the action on the basis of the moving party's papers if a *pro se* party does not file a response; and
- (3) A *pro se* party must identify all facts stated by the moving party with which the *pro*

*se* party disagrees and must set forth the *pro se* party's version of the facts by offering affidavits (written statements signed before a notary public and under oath) or by filing sworn statements (bearing a certificate that it is signed under penalty of perjury); and

(4) A *pro se* party is also entitled to file a legal brief in opposition to the one filed by the moving party.
