**MEMORANDUM IN OPPOSITION TO TBE PLAN B**

Non-party Donald Garrett (“Garrett”), appearing *pro se*, submits this memorandum in opposition to TBE Plan B, submitted by Bull Elephant Media, LLC (ECF No. 222, at 3-4), under the Court’s Order of September 24, 2015 (ECF No. 239). TBE Plan B would dilute the voting power of Asian Americans in Northern Virginia. While Bull Elephant Media, LLC did not submit shapefiles or data accompanying its plan<sup>1</sup>, Garrett did his best to correlate the shape of the map with data from the US Census Bureau.

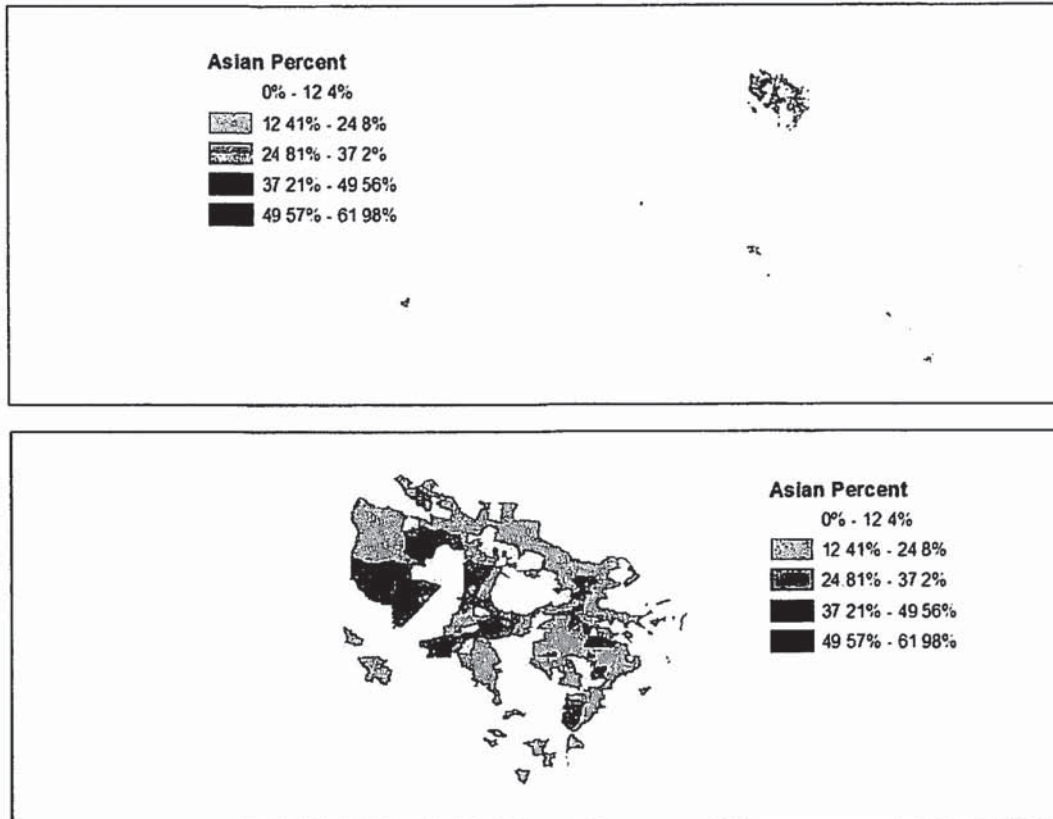
“[S]chemes violate the Fourteenth Amendment when they are adopted with a discriminatory purpose and have the effect of diluting minority voting strength.” *Shaw v. Reno*, 509 U.S. 630, 641 (1993). Figure 1 shows a map of Virginia shaded to show the percent

population of Asian-Americans in each census block, according to the results of the 2013 American Community Survey.

**Figure 1: Asian-American Population by Census Block (2013)**

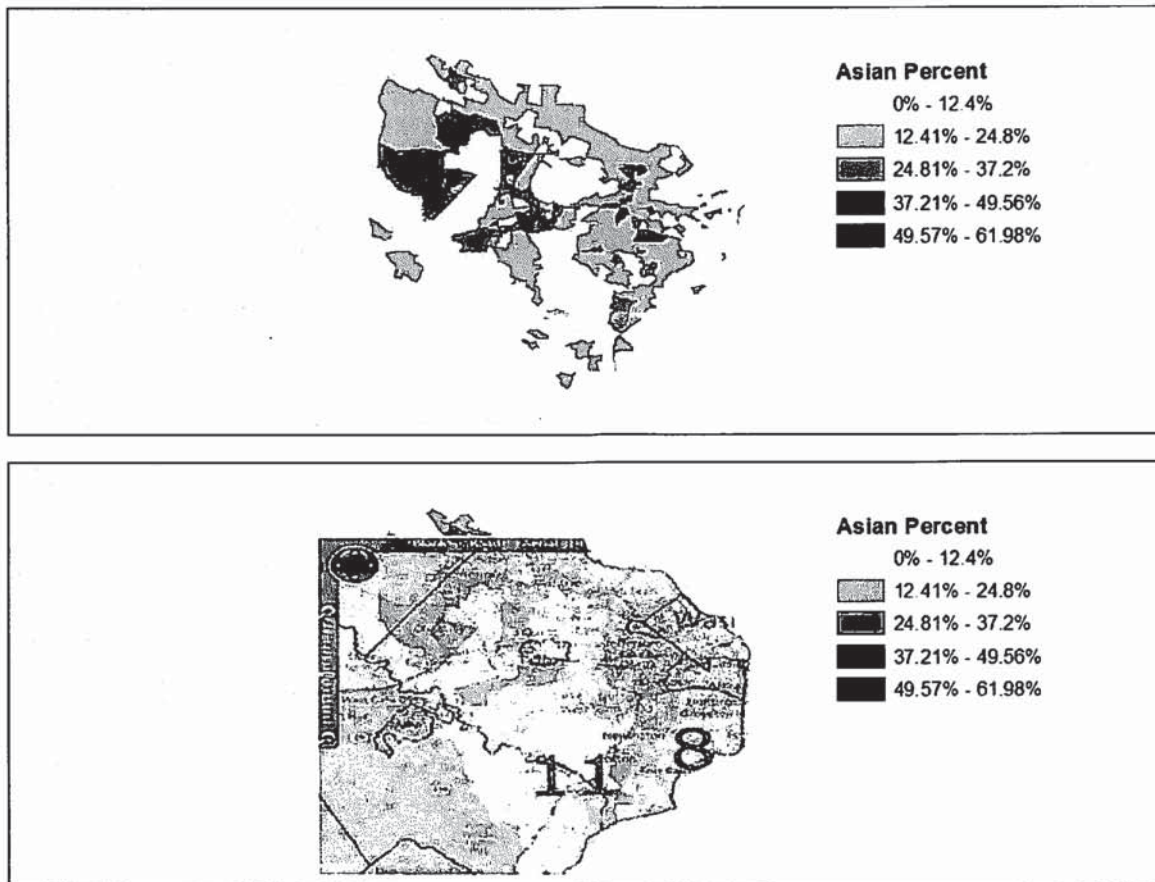


The map shows the census blocks with the highest concentration of Asian-Americans live in the Northern Virginia area, just outside of the District of Columbia.

Figure 2 (below) shows an overlay of TBE Plan B with a map of census blocks in Virginia showing the percent of the population that is Asian, according to 2013 data from the US Census Bureau.<sup>2</sup> At first glance, the 8th, 10<sup>th</sup>, and 11<sup>th</sup> districts of TBE Plan B appear to be deliberately drawn to break up census blocks in Virginia that have as high as a 62% Asian population.

**Figure 2: TBE Plan B and Asian Population Overlay**



The data tables submitted by Bull Elephant Media, LLC, when compared with the current congressional districts, support this postulation. The districts under TBE Plan B would lower the percentage of Asian-American voters in the 8<sup>th</sup> and 11<sup>th</sup> districts. This is summarized below in Table 1.

**Table 1: Percent Asian Population TBE Plan B Compared with Current Congressional Districts**

District	Current Districts	TBE Plan B	Percent Change
8	12.2%	10.9%	-1.3%
10	13.6%	13.6%	-0.0%
11	18%	15.6%	-2.4%

For the courts strike down a congressional district map under the Voting Rights Act, a party must prove the proposal “subordinated traditional race-neutral districting principles,

including but not limited to compactness, contiguity, and respect for political subdivisions or communities defined by actual shared interests, to racial considerations.” *Miller v. Johnson*, 515 U.S. 990, 916 (1995). Garrett questions the racial intentions behind the company and its affiliates and believes subverting the political will of Asian-American communities was the predominate factor in TBE Plan B.

Figure 2 (below) shows a screenshot of a contribution Jeanine Martin (“Martin”) made to a website of Bull Elephant Media, LLC. It is important to note that Martin is a regular contributor to the outlets of Bull Elephant Media, LLC and a frequent participant in the State Central Committee of the Republican Party of Virginia. Figure 2 (below) shows her use of the racial slur “Hmong” to describe Asian-Americans.<sup>3</sup>

**Jeanine Martin**

People are sick to death of illegals and many of the legals. Do we really need hundreds of thousand of Hmong's continuing to pour into the country? Not all cultures are equal and we don't need them all competing for American jobs.

Martin received rebuke for the use of this term from the Vice Chair of the Republican Party of Virginia and an Asian-American candidate for local office.<sup>4</sup> While Bull Elephant Media, LLC claims TBE Plan B was made with the intent of preserving the political desires of the General

Assembly, compactness, and the like (ECF No. 222, at 2-3), Garrett believes these reasons are a façade for the primary racial intent behind TBE Plan B.

In conclusion, Garrett asks this Court to deny the approval of TBE Plan B on the grounds that it violates the Voting Rights Act of 1965.
