**ORDER**

The background of this order is as follows: On approximately February 14, 2002, Plaintiffs filed a subpoena *duces tecum* upon the Custodian of Records of Carnegie Mellon University ("CMU"). Plaintiffs sought from the Custodian certain records pertaining to work that CMU did on behalf of the Republican Caucus of the Pennsylvania House of Representatives ("Republican Caucus"). According to Plaintiffs, CMU performed complex statistical analysis that related to the census data and Act 1. On February 19, 2002, the Republican Caucus filed a motion to intervene for the limited purpose of joining the motion to quash the subpoena *duces tecum*. Accordingly, **IT IS HEREBY ORDERED THAT** the Republican Caucus's motion to intervene is **GRANTED**.
