
O R D E R

gerrymander in violation of the Equal Protection Clause; and

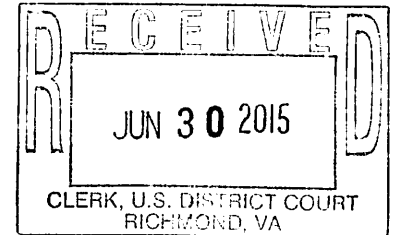
