**PLAINTIFFS' AND DEFENDANTS' STIPULATED AMENDMENT TO THE CASE**  
**SCHEDULE**

Pursuant to the Court's written instructions in an email dated March 28, 2014, counsel for Plaintiffs Dawn Curry Page, Gloria Personhuballah, and James Farkas; Defendants Charlie Judd, Kimberly Bowers, and Don Palmer; and Intervenor-Defendants Congressmen Eric Cantor, Robert Wittman, Bob Goodlatte, Frank R. Wolf, Randy Forbes, Morgan Griffith, Scott Rigell, and Robert Hurt have conferred and propose the following change to the deadline for witness, exhibit, and deposition designations. No other deadlines have been changed from the Joint Status Report and Proposed Schedule filed on February 7, 2014, Dkt. No. 55, and ordered by the Court on February 12, 2014, Dkt. No. 58.

- **Witness, Exhibit, and Deposition Designations:** The parties will exchange by April 11, 2014, witness lists and short summaries of each witness's testimony. The parties also will exchange by April 11, 2014, exhibit lists, copies of exhibits, and deposition designations for all discovery conducted before April 4, 2014. For any depositions taken after April 4, 2014, in accordance with either the Joint Status Report and Proposed Schedule filed on February 7, 2014, Dkt. No. 55, or this Court's March 31, 2014, Order, Dkt. No. 66, the parties will exchange deposition designations,

supplemental exhibit lists, copies of exhibits related only to the depositions taken, and corresponding documents produced after April 4, 2014, within seven days of the relevant deposition. Objections to any exhibit, witness, or deposition designation must be served on the designating party within four business days of designation.

- **Trial Briefs:** The parties will file trial briefs by April 16, 2014.
- **Motions in Limine:** The parties will file any motions in limine by April 25, 2014.
