# Second Amended Consolidated Original Action Complaint

For their Second Amended Consolidated Original Action Complaint, Bonnie Miller, Arkansas Voters First ("AVF"), and Open Primaries Arkansas (collectively, "Petitioners") state:

## Jurisdiction & Parties

- 1. This is an original action under Amendment 7 to the Arkansas Constitution and this Court's Rule 6-5.
- 2. This Court has original and exclusive jurisdiction and venue to review the sufficiency of statewide initiative petitions, including whether the Secretary wrongly denied a cure period.
- 3. Petitioner Bonnie Miller, is an Arkansas citizen, resident, and registered voter.
- 4. Petitioner AVF is an Arkansas ballot question committee duly registered with the Arkansas Ethics Commission. **Exhibit 1**, **AVF's Statement of Organization**.
- 5. AVF is the sponsor of the proposed constitutional amendments at issue in this proceeding: the Arkansas Citizens' Redistricting Commission Amendment and a constitutional amendment requiring open primary elections and instant runoff general elections in Arkansas.
- 6. Petitioner OPAR is an Arkansas ballot question committee duly registered with the Arkansas Ethics Commission to support the proposed constitutional amendment regarding open primaries/rank-choice voting sponsored by AVF. Exhibit 2, OPAR Statement of Organization.

- 7. John Thurston is the Arkansas Secretary of State and is charged with reviewing, counting, and certifying the sufficiency of statewide measures. Ark. const., Amend. 7; Ark. Code Ann. § 7-9-126.
- 8. Secretary Thurston is also the chair of the State Board of Election Commissioners, which is charged with certifying the legal sufficiency of the ballot title for statewide measures. Ark. Const., Amendment 7; Ark. Code Ann. § 7-9-111(i).
- 9. Secretary Thurston is the agent for service of process for the State Board of Election Commissioners. ARCP Rule 4(f)(12).

# Factual Background

10. In compliance with Ark. Code Ann. § 7-9-101, et seq., AVF submitted valid initiative petitions to Secretary Thurston on July 6, 2020 in support of two proposed constitutional amendments: Arkansas Citizens' Redistricting Commission Amendment and a proposed constitutional amendment requiring open primary elections and instant runoff general elections in Arkansas. **Exhibits 3** (redistricting) and **4** (open primaries/rank-choice voting).

- 11. In support of the proposed amendment for open primaries/rank-choice voting, AVF submitted 94,913 signatures spanning 15,917 petition parts. **Exhibit 8.**
- 12. In support of the proposed amendment for redistricting, AVF submitted 98,728 signatures spanning 15,118 petition parts. **Exhibit 9.**
- 13. Ark. Code Ann. § 7-9-126(a) provides: "Upon the initial filing of an initiative petition or referendum petition, the official charged with verifying the signatures shall: (1) Perform an initial count of the signatures; and (2) Determine whether the petition contains, on its face and before verification of the signatures of registered voters, the designated number of signatures required by the Arkansas Constitution and statutory law in order to certify the measure for the election ballot."
- 14. To achieve facial validity, and thereby be entitled to a cure period, any petition for a statewide proposed measure in 2020 must contain the following: (1) at least 89,151 total signatures at its face; (2) at least 75% of that total (66,863) must be valid signatures of legal voters; and (3) at least 75% the required number of

signatures of legal voters from each of at least fifteen 15 counties of the state. Ark. const., Amend. 7; Ark. Code Ann. § 7-9-111(d).

- 15. Ark. Code Ann. § 7-9-111(d)(1): "If the signatures submitted on a statewide initiative petition... are found to be insufficient, the Secretary of State shall forthwith notify the sponsors in writing...and shall set forth his or her reasons for so finding. When the notice is delivered, the sponsors shall have thirty (30) days in which to do any or all of the following: (A) Solicit and obtain additional signatures; or (B) Submit proof to show that the rejected signatures or some of them are good and should be counted."
- 16. On July 6, 2020, AVF submitted timely, valid initiative petitions with the requisite accompanying signatures to the Secretary of State.
- 17. The signatures AVF submitted in support of both initiative petitions were at least sufficient to qualify for a cure period to gather additional signatures.
- 18. On July 14, 2020, the Secretary wrote to AVF stating that he was unable to count *any* signatures submitted by AVF in connection with either petition because of the wording of AVF's

certification language (required under Ark. Code Ann. § 7-9-601(b)(3)), which was submitted to the Secretary. **Exhibits 5** (redistricting) and **6** (open primaries/rank-choice voting).

- 19. On July 17, 2020, having no other remedies, AVF filed this original action.
- 20. On July 21, 2020, AVF filed its first amendment to the original action petition to clarify the standing of the two ballot question committees.
- 21. Later that day on July 21, 2020, the Secretary wrote AVF stating additional reasons for not counting thousands more signatures submitted in support of the petition for open primaries/rank-choice voting. **Exhibit 7.**
- 22. On July 22, 2020, the State Board of Election Commissioners met and refused to certify the sufficiency of the popular name and ballot title for open primaries/rank-choice voting.
- 23. The deadline for the Secretary to certify any proposed constitutional amendments to the County Boards of Election Commissioners is August 20, 2020.

# Count 1—The Sufficiency of AVF's Certification Wording

- 24. Petitioners incorporate and adopt all the foregoing paragraphs herein.
- 25. On July 23, 2020, with regard to the redistricting petition, the Secretary wrote AVF the following: "After completion of the intake analysis procedure for the above referenced petition, a total of 4,579 signatures were culled, leaving a total of 90,493 signatures on the face of the petition." **Exhibit 11**. According to the Secretary, the redistricting petition had more than 89,151 facially valid signatures; therefore, the only reason the Secretary refuses to certify the redistricting petition is the wording of the certification language
- 26. The Secretary's decision—refusing to count any signatures submitted by AVF in support of either petition due to the wording in AVF's certification—violates Arkansas law.
- 27. Ark. Code Ann. § 7-9-126(b) provides: "A petition part and all signatures appearing on the petition part shall not be counted for any purpose by the official charged with verifying the signatures, including the initial count of signatures, if one (1) or more of the following is true...(4)(A) [t]he canvasser is a paid canvasser whose name and the information required under § 7-9-

601 were not submitted or updated by the sponsor to the Secretary of State before the petitioner signed the petition."

- 28. Ark. Code Ann. §7-9-601(b)(1) provides: "To verify that there are no criminal offenses on record, a sponsor shall obtain, at the sponsor's cost, from the Division of Arkansas State Police, a current state and federal criminal record search on every paid canvasser to be registered with the Secretary of State; (2) The criminal record search shall be obtained within thirty (30) days before the date that the paid canvasser begins collecting signatures; (3) Upon submission of the sponsor's list of paid canvassers to the Secretary of State, the sponsor shall certify to the Secretary of State that each paid canvasser in the sponsor's employ has passed a criminal background check in accordance with this section."
- 29. Ark. Code Ann. § 7-9-601(f) provides: "Signatures incorrectly obtained or submitted under this section shall not be counted by the Secretary of State for any purpose."
- 30. The original petition parts for both measures have been filed with the Secretary. These documents have not been attached hereto as exhibits because they are too voluminous. They will be

made part of the record before the special master when received from the Secretary.

- 31. When certifying that their paid canvassers had passed a background check in accordance with Ark. Code Ann. § 7-9-601, AVF submitted the following language to the Secretary: In compliance with Arkansas Code § 7-9-601, please find the list of paid canvassers that will be gathering signatures on the Redistricting Amendment for Arkansas Voters First. On behalf of the sponsors, this statement and submission of names serves as certification that a statewide Arkansas State Police background check, as wells as, 50-state criminal background check have been timely acquired in the 30 days before the first day the Paid canvasser begins to collect signatures as required by Act 1104 of 2017. **Exhibit 12**
- 32. When certifying that their paid canvassers had passed a background check in accordance with Ark. Code Ann. § 7-9-601, AVF submitted the following language to the Secretary: In compliance with Arkansas Code § 7-9-601, please find the list of paid canvassers that will be gathering signatures on the Constitutional Amendment Establishing Top Four Open Primary

Elections And Majority Winner General Elections With Instant Runoff Period. On behalf of the sponsors, this statement and submission of names serves as certification that a statewide Arkansas State Police background check, as wells as, 50-state criminal background check have been timely acquired in the 30 days before the first day the Paid canvasser begins to collect signatures as required by Act 1104 of 2017. **Exhibit 13** 

- 33. The certification emails were numerous and ongoing. They have been requested from the Secretary's office and will be made part of the record as soon as the Secretary provides copies of what he relied on when refusing to count signatures.
- 34. The Secretary considered this language insufficient under Ark. Code Ann. § 7-9-601 because, in his view, the language should have said "passed" instead of "acquired." **Exhibits 5 and 6**.
- 35. This was, at least initially, the sole basis on which the Secretary refused to count AVF's signatures for both initiative petitions.
- 36. Ark. Code Ann. § 7-9-601(b)(1) provides, "To verify that there are no criminal offenses on record, a sponsor shall obtain, at the sponsor's cost, from the Division of Arkansas State Police, a

current state and federal criminal record search on every paid canvasser to be registered with the Secretary of State."

- 37. Citing Ark. Code Ann. § 7-9-601(b)(3), the Secretary claimed in his insufficiency letter that the petitions were insufficient, that none of the signatures may be counted for any purpose, and that he was statutorily prohibited from counting the submitted signatures for any purpose.
- 38. The Secretary's summation of the certification language provided by AVF regarding paid canvassers is incomplete. Notably, the certifications each indicated that they were in compliance with "Ark. Code Ann § 7-9-601" and "Act 1104 of 2017."
- 39. The Secretary's refusal to count any of the signatures provided by AVF violates Ark. Code Ann. §§ 7-9-126, 7-9-6011, and 7-9-111.
- 40. The Secretary's decision is also arbitrary and capricious because it is contrary to his position regarding the certification language submitted in in support of Safe Surgery Arkansas in *Arkansas for Healthy Eyes v. Thurston*, Arkansas Supreme Court Case No. CV 20-136. In that case, the Secretary counted signatures submitted with the same certification language. His decision to

reverse course is arbitrary and capricious, thwarts the statewide initiative process, and threatens to disenfranchise tens of thousands of voters.

- 41. AVF's initiative petitions met the statutory requirements for statewide initiative measures.
- 42. Additionally, AVF is entitled to a 30-day "cure period," which this Court has granted, provisionally.
- 43. This Court has consistently held that, to qualify for additional time, a petitioner must only make a prima facie showing that it has submitted the requisite number of valid signatures of legal voters to qualify the petition for the cure. *Ark. Hotels & Entm't, Inc. v. Martin*, 2012 Ark. 335, 423 S.W.3d 49; *Ellis v. Hall*, 219 Ark. 869, 245 S.W.2d 223 (1952); *Dixon v. Hall*, 210 Ark. 891, 198 S.W.2d 1002 (1946).
- 44. This Court's only concern when examining a decision by the Secretary regarding whether to grant a cure period is straightforward: whether the petition, on its face, contains "a sufficient number of signatures pursuant to both the state-wide and fifteen-county requirement." Stephens v. Martin, 2014 Ark. 442, 9, 491 S.W.3d 451, 456.

- 45. On July 6, 2020, AVF filed petitions that met all the facial validity requirements in Arkansas law.
- 46. As a result, AVF is entitled to a cure period of 30 days under well-settled Arkansas law.
- 47. The Secretary violated Ark. Code Ann § 7-9-126 by flatly refusing to count any of the signatures provided by AVF and refusing to provide a cure period.
- 48. Each day that passes without the Secretary counting signatures makes the certifying of these measures for the ballot much more difficult.
- 49. Pursuant to A.R.C.P. 65, the Court should enter a preliminary and permanent injunction compelling the Secretary of State to begin counting the signatures provided by Arkansas Voters First within three days or less. The preliminary injunction should be issued immediately and without notice to the Arkansas Secretary of State. Petitioners will be irreparably harmed by not having their signatures counted in a very timely manner in the fast-approaching run-up to the November election.

Count 2—The Secretary's Purported Additional Grounds to Disqualify AVF's Signatures for Open Primaries/Rank-Choice Voting

- 50. Petitioners adopt and incorporate herein all the foregoing paragraphs.
- 51. On July 21, 2020, the Secretary stated additional reasons why he had decided to not count certain signatures submitted by AVF in support the proposed amendment for open primaries/rank-choice voting. **Exhibit 7.**
- 52. On information and belief, at least some of those signatures were wrongly excluded from the Secretary's counting.
- 53. After stating that he was prohibited from counting signatures for any purpose, the Secretary stated that he indeed counted signatures and determined that, after culling these signatures on various grounds, the face of the petition for open primaries/rank-choice voting had only 88,623 signatures on its face.
- 54. Under the Secretary's counting, the open primaries/rank-choice voting amendment is only 528 signatures short of the gross signatures required.

- 55. When the wrongly excluded signatures are thrown-back into the counting, AVF's petition on open primaries/rank-choice voting qualifies for the cure.
- 56. Ark. Code Ann. § 7-9-601(d)(3) requires sponsors to affirm something that is impossible because the Arkansas State Police are not permitted to obtain federal background checks on paid canvassers under the statute.

# Count 3—The Sufficiency of the Ballot Title and Popular Name for Open Primaries/Rank-Choice Voting

- 57. Petitioners adopt and incorporate herein all the foregoing paragraphs.
- 58. Secretary Thurston is both the Chair and the Secretary of the State Board of Election Commissioners ("SBEC"). Ark. Code Ann. § 7-4-101(b).
- 59. The SBEC is charged by Amendment 7 with certifying the ballot titles for proposed statewide measures. Ark. const. Amendment 7 ("Title").
- 60. Act 376 of 2019 adds several additional duties to the SBEC in connection with a proposed statewide measures. *See* Ark. Code Ann. § 7-9-111(i).

- 61. The SBEC is charged with "determin[ing] whether to certify the ballot title and popular name...for a proposed measure" within 30 days after receiving it from the Secretary of State. Ark. Code Ann. § 7-9-111(i)(2).
- 62. If the SBEC determines that "the ballot title and popular name, and the nature of the issue, [are] presented in a manner that is not misleading and not designed in such a manner that a vote 'FOR' the issue would be a vote against the matter or viewpoint that the voter believes himself or herself to be casting a vote for, or, conversely, that a vote 'AGAINST' an issue would be a vote for a viewpoint that the voter is against," then the proposed measure "shall be certified to the Secretary of State to be placed upon the ballot" pending the determination of having sufficient signatures." Ark. Code Ann. § 7-9-111(i)(3).
- 63. But if the SBEC determines "that the ballot title or popular name, or the nature of the issue, is presented in such a manner that the ballot title or popular name would be misleading or designed in such manner that a vote 'FOR' the issue would be a vote against the matter or viewpoint that the voter believes himself or herself to be casting a vote for, or, conversely, that a vote

'AGAINST' an issue would be a vote for a viewpoint that the voter is against, the board of shall...(i) Not certify the ballot title and popular...." Ark. Code Ann. § 7-9-111(i)(4)(a)(i).

- 64. If the ballot title and popular name are not certified, then the SBEC must notify the sponsor, "in writing, that the ballot title and popular name were not certified and set forth its reasons for so finding." Ark. Code Ann. § 7-9-111(i)(4)(a)(ii).
- 65. If it refuses to certify the ballot title and popular name, the SBEC must also notify the Secretary of State of that refusal. Ark. Code Ann. § 7-9-111(i)(4)(a)(iii).
- 66. Upon receiving that notice from the SBEC, the Secretary of State is required to declare the proposed measure insufficient for the ballot. Ark. Code Ann. § 7-9-111(i)(4)(b).
- 67. On July 22, 2020, the SBEC met to consider the ballot title and popular name for the open primaries/rank-choice voting proposed amendment.
- 68. At that meeting, the SBEC refused to certify the ballot title and popular name.

- 69. The SBEC has not yet notified AVF in writing of that decision and the reasons for it as required by Ark. Code Ann. § 7-9-111(i)(4)(a)(ii).
- 70. When AVF receives the required writing from the SBEC, AVF will supplement the record.
- 71. The complete popular name, ballot title, and text for open primaries/rank-choice voting is attached as **Exhibit 10**.
- 72. On information and belief, the SBEC has already notified the Secretary as required by Ark. Code Ann. § 7-9-111(i)(4)(a)(iii).
- 73. The SBEC's refusal to certify the popular name and ballot title for the open primaries/rank-choice voting proposed amendment was contrary to Arkansas law governing the legal sufficiency of popular names and ballot titles.

## WHEREFORE, AVF respectfully asks this Court to:

(1) enter a preliminary and permanent injunction, without notice to the Arkansas Secretary of State, compelling the Arkansas Secretary of State to begin counting the signatures provided by Arkansas Voters First in support of their respective initiative petitions, immediately;

- (2) order the Secretary of State to provide AVF with a "cure period" of at least 30 days on both petitions;
- (3) send the factual matters raised in Count 2 to special master Judge Fogleman to be made part of the existing proceedings on the factual matters now categorized as Count 1 and already referred to Judge Fogleman;
- (4) bifurcate Count 3 for consideration on its own and to set a briefing schedule; and
- (5) award AVF all other just and proper relief to which it is entitled.





### **Ballot Title**

An Amendment to the Arkansas Constitution requiring that all qualified electors be permitted to vote in a primary election, which must use a single ballot that lists all candidates for a covered office for whom that elector can vote regardless of political-party affiliation (or lack thereof) of the elector or candidate; defining the term "covered office" to mean each federal congressional office, each member of the General Assembly, and the Governor, Lieutenant Governor, Secretary of State, Treasurer of State, Auditor of State, Attorney General, and Commissioner of State Lands; providing that "covered office" does not include the Office of the President of the United States; defining "qualified elector" to mean a person who meets the requirements of Arkansas Constitution, article 3, § 1 and Amendment 51; providing that the four candidates for each covered office at a primary election who receive the most votes, regardless of party, will then appear on the general-election ballot for that covered office, and requiring that no other candidates can appear on the general-election ballot for a covered office; providing that, at a general election for a covered office, qualified electors may rank one or more candidates in order of preference; requiring that the winner of a general election for a covered office be determined through an instant runoff process where votes must first be counted based on first-choice rankings; establishing that if, after counting votes according to first-choice rankings, a candidate has a majority of votes, that candidate must be declared the winner; providing that if no candidate has a majority of the votes, then the candidate with the fewest votes is eliminated and the vote of each qualified elector whose first choice was the eliminated candidate is then counted for the elector's next-choice candidate (if any); providing that if a candidate then has a majority of votes remaining, that candidate must be declared the winner; providing that if no candidate has a majority of the votes, then the candidate with the fewest votes is eliminated and the vote of each qualified elector whose next choice was the eliminated candidate is then counted for the elector's next-choice candidate (if any); providing that if a candidate then has a majority of votes remaining, they must be declared the winner; providing that candidates for a covered office at a primary election, and at a general election, may choose to have their political-party affiliation indicated on the ballot; providing that such an indication will not constitute or imply the political party's nomination, endorsement, or selection of the candidate; providing that political parties may have their preferences for candidates for a covered office indicated on the primary and general election ballots and may also nominate, endorse, support, or oppose any candidate; and requiring the General Assembly to enact legislation to provide for a revised election process in accordance with and in furtherance of this Amendment: providing that all provisions of the Constitution, statutes, and common law of this State to the extent inconsistent or in conflict with any provision of this Amendment are expressly declared null and void as to, and do not apply to, any activities provided for under this Amendment.

### Section 1. Short title

This Amendment is known as and should be cited as the "Top Four Open Primaries and Majority Winner Amendment."

### Section 2. Definitions

- (A) (1) "Covered office" means an elective office for federal congressional office, each member of the General Assembly, and the Governor, Lieutenant Governor, Secretary of State, Treasurer of State, Auditor of State, Attorney General, and Commissioner of State Lands.
  - (2) "Covered office" does not mean the office of the President of the United States.
- (B) "Qualified elector" means a person who meets the qualifications of an elector under Arkansas Constitution, article 3, § 1, and who is registered pursuant to Arkansas Constitution, Amendment 51.

### Section 3: Top Four Open Primary Elections

- (A) The primary election for a covered office shall be a top four open primary election.
- (B) In a top four open primary election,



- (1) All candidates for a covered office must appear on the same ballot regardless of political-party affiliation.
- (2) The ballot must include space for a write-in candidate for a covered office.
- (3) A qualified elector must be permitted to cast a vote for any candidate for a covered office for whom that elector can vote, regardless of the political-party affiliation (or lack thereof) of the qualified elector or of the candidate for whom the elector cast a vote.
- (4) Candidates for a covered office may have their political-party affiliation indicated on the ballot.
  - (a) The candidate's designation of such an affiliation will not constitute or imply the nomination, endorsement, or selection of the candidate by the political party designated.
- (5) Political parties may choose to have their preferences for candidates for a covered office indicated on the ballot.
  - (a) Nothing herein limits the right of political parties to endorse, support, or oppose any candidate.
- (6) Each qualified elector may vote for one candidate for a covered office. The four candidates for each covered office receiving the most votes in the top four open primary must advance to the general election for that covered office.
  - (a) No other candidates for a covered office may appear on the general-election ballot.

### Section 4. Majority Winner through Instant Runoff at General Election

- (A) The general election for a covered office shall be an instant runoff general election to ensure a majority winner.
- (B) In an instant runoff general election.
  - (1) Candidates may have their political-party affiliation indicated on the ballot.
    - (a) The candidate's designation of such an affiliation will not constitute or imply the nomination, endorsement, or selection of the candidate by the political party designated.
  - (2) Political parties may choose to have their candidate preferences indicated on the ballot.
    - (a) Nothing herein limits the right of political parties to endorse, support, or oppose any candidate.
  - (3) A qualified elector may cast a vote for a covered office by ranking one or more candidates for that office. No elector is required to rank more than one candidate.
  - (4) To determine the winner of an election for a covered office, votes must first be counted based on first-choice rankings. If any candidate has a majority of such votes, that candidate must be declared the winner.
  - (5) If, after counting votes according to first-choice rankings, no candidate has a majority of such votes, then the following process begins:
    - (a) The candidate with the fewest votes is eliminated.
    - (b) The vote of each qualified elector whose first choice was the eliminated candidate described in section 4(B)(5)(a) is then counted for that elector's next-choice candidate instead, should a next choice be marked.
    - (c) If a candidate then has a majority of all remaining votes, that candidate must be declared the winner.

- (6) If no candidate has a majority of the remaining votes after the instant-runoff process described in subsection (B)(5) of this section, then the instant-runoff process continues:
  - (a) The candidate with the fewest votes is eliminated.
  - (b) The vote of each qualified elector whose vote was counted for the eliminated candidate described in section 4(B)(6)(a) is then counted for that elector's next-choice candidate instead, should a next choice be marked.
  - (c) A candidate will then have a majority of all remaining votes, and that candidate must be declared the winner.

### Section 5. General Assembly

The General Assembly is required to enact legislation to provide for a revised election process in accordance with and in furtherance of this Amendment.

### Section 6. Inconsistent provisions

All provisions of the Constitution, statutes, and common law of this State to the extent inconsistent or in conflict with any provision of this Amendment are expressly declared null and void as to, and do not apply to, any activities provided for under this Amendment.

### Section 7. Severability

If any provision or section of this Amendment or the application thereof to any person or circumstance is held invalid, such invalidity will not affect any other provision or application of the Amendment that can be given effect without the invalid provisions or applications, and to this end the provisions of this Amendment are declared to be severable.

### Section 8. Effective date.

This Amendment becomes effective on January 1, 2021.


