Counsel for the State has contacted counsel for Plaintiffs to explain that while the State originally believed the Court had set these matters for a two-week trial, the State now believes the Court's orders sets a five-day trial for both the *Soto Palmer* and *Garcia* matters.

Counsel for the State indicates that the Commissioners' counsel's belief that the trial is ten days likely came from conversations with counsel for the State.

In any event, Plaintiffs understand the confusion, because each case is separately set for trials of 5 days (*Soto Palmer*) and 4-5 days (*Garcia*). A 5-day combined trial is not sufficient time.
